1 A BILL for an Act to amend and reenact section 1-01-49, subdivision g of subsection 1 of
2 section 12.1-32-15, subdivision b of subsection 1 of section 14-07.6-01, section 18-01-36,
3 subdivision j of subsection 4 of section 27-20.3-16, subsection 19 of section 45-13-01,
4 subsection 7 of section 49-02-02, section 52-02-18, subsection 5 of section 54-10-28, section
5 54-52.6-02.2, subsection 3 of section 57-02-08.8, subsection 2 of section 57-38-30.3, and
6 subsection 1 of section 57-40.5-03 of the North Dakota Century Code, relating to technical
7 corrections and improper, inaccurate, redundant, missing, or obsolete references; to repeal
8 sections 1-01-18, 1-01-20, 1-01-21, 1-01-27, 1-01-29, 1-01-30, 1-01-36, 1-01-40, 1-01-41,
9 1-01-42, 1-01-45, 1-01-46, 1-01-47, and 1-01-51 of the North Dakota Century Code, relating to
10 technical corrections and improper, inaccurate, redundant, missing, or obsolete references; and
11 to provide an effective date.

12 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

13 **SECTION 1. AMENDMENT.** Section 1-01-49 of the North Dakota Century Code is amended
14 and reenacted as follows:

15 **1-01-49. Other general definitions.**

16 As used in this code, unless the context otherwise requires or unless otherwise defined:

- 17 1. "Children" includes children by birth and by adoption.
18 2. "Coal" means all kinds of coal and includes what is known as lignite coal.
19 3. "Compound interest" means interest added to the principal as the interest becomes
20 due and which thereafter bears interest.
21 4. "Corporate surety" means a corporation or limited liability company duly authorized
22 under the laws of this state to transact a surety business in the state.
23 5. "Decree" has the same meaning as the word "judgment".
24 6. "Depose" includes every mode of written statement under oath or affirmation.

20 Columbia and the territories.
21 ~~21-31.~~ "Testify" includes every mode of oral statement under oath or affirmation.

23 concerning which the phrase is used.
24 33. "United States" includes the District of Columbia and the territories.
25 ~~23-34.~~ "Value" or "valuable consideration" means something of value parted with, or a new
26 obligation assumed at the time of obtaining something, which serves as substantial
27 compensation for what is received in return.
28 35. "Verdict" includes not only the verdict of a jury, but also the finding upon the facts of a
29 judge or of a master appointed to determine the issues in a cause.
30 36. "Verified" means sworn to before an officer authorized to administer oaths.
31 37. "Will" includes codicils.

3 **SECTION 2. AMENDMENT.** Subdivision g of subsection 1 of section 12.1-32-15 of the
4 North Dakota Century Code is amended and reenacted as follows:

5 g. "Sexual offender" means a person who has pled guilty to or been found guilty,
6 including juvenile delinquent adjudications, of a violation of section 12.1-20-03,
7 12.1-20-03.1, 12.1-20-04, 12.1-20-05, 12.1-20-05.1, 12.1-20-06, 12.1-20-06.1,
8 12.1-20-07 except for subdivision a of subsection 1, 12.1-20-11, 12.1-20-12.1,
9 12.1-20-12.2, 12.1-20-12.3 except for subdivision a of subsection 1 and
10 subdivision b of subsection 1 if the offense involves only a demand for money,
11 chapter 12.1-27.2, ~~subsection 2 of section 12.1-22-03.1~~, subdivision b of
12 subsection 1 of section 12.1-41-02, section 12.1-41-04, 12.1-41-05, or
13 12.1-41-06, or an equivalent offense from another court in the United States, a
14 tribal court, or court of another country, or an attempt or conspiracy to commit
15 these offenses.

16 **SECTION 3. AMENDMENT.** Subdivision b of subsection 1 of section 14-07.6-01 of the
17 North Dakota Century Code is amended and reenacted as follows:

18 b. The filing party has been found by a court to have committed an act of domestic
19 violence or disorderly conduct against the opposing party pursuant to a court
20 order entered under chapter 14-07.1, 14-09, or ~~12.1-32-2~~12.1-31.2, or an
21 equivalent ordinance from another state, provided the issuing court made a
22 specific finding of domestic violence or disorderly conduct, or the filing party has
23 a prior conviction relating to domestic violence against the opposing party under
24 chapter 12.1-17;

25 **SECTION 4. AMENDMENT.** Section 18-01-36 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **18-01-36. Petroleum tank release compensation fund fees.**

28 The insurance commissioner shall charge and collect fees for services provided by the state
29 fire marshal program to entities covered by the petroleum tank release compensation fund
30 under chapter ~~23-37~~23.1-12. All fees collected under this section must be deposited in the
31 insurance regulatory trust fund.

1 **SECTION 5. AMENDMENT.** Subdivision j of subsection 4 of section 27-20.3-16 of the North
2 Dakota Century Code is amended and reenacted as follows:

3 j. That permanency hearing must be as set forth in section ~~27-20.3-36~~27-20.3-26;

5 **SECTION 6. AMENDMENT.** Subsection 19 of section 45-13-01 of the North Dakota
6 Century Code is amended and reenacted as follows:

7 19. "Partnership" means an association of two or more persons to carry on as co-owners
8 of a business for profit formed under section 45-14-02, predecessor law, or
9 comparable law of another jurisdiction.

10 **SECTION 7. AMENDMENT.** Subsection 7 of section 49-02-02 of the North Dakota Century
11 Code is amended and reenacted as follows:

12 7. Cooperate with and receive technical and financial assistance from the United States,
13 any state, or any department, agency, or officer thereof for any purposes relating to
14 federal energy laws that deal with energy conservation, coal conversion, rate reform,
15 and utilities subject to the jurisdiction of the commission. The commission shall also
16 have the authority to file any reports, hold hearings, and promulgate regulations for
17 any such purposes. Information received by the commission which was developed or
18 obtained by a regional transmission organization market monitor, the organization of
19 midwestmidcontinent independent system operator states, and the southwest power
20 pool regional state committee is exempt from section 44-04-18 and section 6 of
21 article XI of the Constitution of North Dakota.

22 **SECTION 8. AMENDMENT.** Section 52-02-18 of the North Dakota Century Code is
23 amended and reenacted as follows:

24 **52-02-18. Independent performance audit.**

25 The state auditor, upon request of the legislative audit and fiscal review committee, shall
26 cause a performance audit of job service North Dakota to be conducted within twelve months
27 after receipt of the request. The state auditor may appoint an independent audit firm, with
28 extensive expertise in job service practices and standards, to complete a performance audit or
29 the state auditor may conduct the performance audit. If the state auditor completes the audit,
30 the state auditor may contract with a consulting firm to aid in the state audit or to complete the
31 audit and shall charge job service North Dakota for the audit, including the services of the

1 consulting firm. The executive director of job service North Dakota and the auditor shall present
2 the audit report and any action taken as a result of the audit to the legislative audit and fiscal
3 review committee and to the house ~~and senate~~ industry, business and labor standing
4 ~~committees~~committee and the senate industry and business standing committee during the next
5 regular session of the legislative assembly following the audit.

6 **SECTION 9. AMENDMENT.** Subsection 5 of section 54-10-28 of the North Dakota Century
7 Code is amended and reenacted as follows:

8 5. Present results of information technology compliance reviews to the information

10 **SECTION 10. AMENDMENT.** Section 54-52.6-02.2 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 **54-52.6-02.2. Election after December 31, 2024 - Additional employer contribution.**
13 **(Effective after December 31, 2024)**

14 1. As used in this section, "eligible employee" means a permanent state employee who
15 on December 31, 2024, is a participating member of the public employees retirement
16 system main system plan under chapter ~~54-42~~54-52, who has been a participating
17 member under chapter 54-52 for no more than five years, and who is at least eighteen
18 years of age.

19 2. The board shall provide a three-month election period, from January 1, 2025, through
20 March 31, 2025, for an eligible employee to transfer to the defined contribution plan
21 under this chapter pursuant to the rules and policies adopted by the board.

22 a. An election under this section made by a member of the public employees
23 retirement system under chapter 54-52 to transfer to the defined contribution
24 retirement plan under this chapter is irrevocable.

25 b. For an eligible employee who elects to transfer from the public employees
26 retirement system under chapter 54-52 to the defined contribution retirement plan
27 under this chapter, the board shall transfer a lump sum amount from the public
28 employees retirement system fund to the member's account in the defined
29 contribution retirement plan under this chapter. However, if the eligible employee
30 terminates employment before receiving the lump sum transfer under this
31 section, the election made is ineffective and the eligible employee remains a

1 member of the public employees retirement system under chapter 54-52 and
2 retains all the rights and privileges under that chapter.

3 c. The board shall calculate the lump sum amount to be transferred based on the
4 actuarial present value of the eligible employee's accumulated benefit obligation
5 under the public employees retirement system based on the assumption the
6 eligible employee will retire under the earlier applicable normal retirement age,
7 plus interest from January 1, 2025, to the date of transfer, at the rate of one-half
8 of one percent less than the actuarial interest assumption at the time of the
9 election.

10 d. This section does not affect an eligible individual's right to health benefits under
11 chapter 54-52.1.

12 3. The state employer of an eligible employee who elects under this section to participate
13 in the defined contribution retirement plan under this chapter shall pay an additional
14 annual contribution of three thousand three hundred and thirty-three dollars for up to
15 three years. Under this subsection, the employer shall pay the additional contribution
16 each year the eligible employee continues permanent employment with the state,
17 beginning January 2026, and extending no further than January 2028.

18 4. If the board receives notification from the internal revenue service that this section or
19 any portion of this section will cause the public employees retirement system or the
20 retirement plan established under this chapter to be disqualified for tax purposes
21 under the Internal Revenue Code, that portion that will cause the disqualification does
22 not apply.

23 **Election after the day before the effective date of this Act - Additional employer**
24 **contribution. (Effective on the date identified if the contingency is satisfied) (Contingent**
25 **effective date - [See note](#))**

26 1. As used in this section, "eligible employee" means a permanent state employee who
27 on the day before the effective date of this Act, is a participating member of the public
28 employees retirement system main system plan under chapter ~~54-4254-52~~, who has
29 been a participating member under chapter 54-52 for no more than five years, and
30 who is at least eighteen years of age.

- 1 2. The board shall provide a three-month election period, beginning on the effective date
2 of this Act, for an eligible employee to transfer to the defined contribution plan under
3 this chapter pursuant to the rules and policies adopted by the board.
- 4 a. An election under this section made by a member of the public employees
5 retirement system under chapter 54-52 to transfer to the defined contribution
6 retirement plan under this chapter is irrevocable.
- 7 b. For an eligible employee who elects to transfer from the public employees
8 retirement system under chapter 54-52 to the defined contribution retirement plan
9 under this chapter, the board shall transfer a lump sum amount from the public
10 employees retirement system fund to the member's account in the defined
11 contribution retirement plan under this chapter. However, if the eligible employee
12 terminates employment before receiving the lump sum transfer under this
13 section, the election made is ineffective and the eligible employee remains a
14 member of the public employees retirement system under chapter 54-52 and
15 retains all the rights and privileges under that chapter.
- 16 c. The board shall calculate the lump sum amount to be transferred based on the
17 actuarial present value of the eligible employee's accumulated benefit obligation
18 under the public employees retirement system based on the assumption the
19 eligible employee will retire under the earlier applicable normal retirement age,
20 plus interest from the effective date of this Act, to the date of transfer, at the rate
21 of one-half of one percent less than the actuarial interest assumption at the time
22 of the election.
- 23 d. This section does not affect an eligible individual's right to health benefits under
24 chapter 54-52.1.
- 25 3. The state employer of an eligible employee who elects under this section to participate
26 in the defined contribution retirement plan under this chapter shall pay an additional
27 annual contribution of three thousand three hundred and thirty-three dollars for up to
28 three years. Under this subsection, the employer shall pay the additional contribution
29 each year the eligible employee continues permanent employment with the state,
30 beginning one year after the effective date of this Act, and extending no further than
31 three years following the effective date of this Act.

- 1 4. If the board receives notification from the internal revenue service that this section or
2 any portion of this section will cause the public employees retirement system or the
3 retirement plan established under this chapter to be disqualified for tax purposes
4 under the Internal Revenue Code, that portion that will cause the disqualification does
5 not apply.

6 **SECTION 11. AMENDMENT.** Subsection 3 of section 57-02-08.8 of the North Dakota
7 Century Code is amended and reenacted as follows:

- 8 3. A disabled veteran or ~~unremarried~~ surviving spouse claiming a credit under this
9 section for the first time shall file with the county auditor an affidavit showing the facts
10 required under this section, a description of the property, and a certificate from the
11 United States department of veterans' affairs, or its successor, certifying to the amount
12 of the disability. The affidavit and certificate must be open for public inspection. A
13 person shall thereafter furnish to the assessor or other assessment officials, when
14 requested to do so, any information which supports the claim for credit for any
15 subsequent year.

16 **SECTION 12. AMENDMENT.** Subsection 2 of section 57-38-30.3 of the North Dakota
17 Century Code is amended and reenacted as follows:

- 18 2. For purposes of this section, "North Dakota taxable income" means the federal taxable
19 income of an individual, estate, or trust as computed under the Internal Revenue Code
20 of 1986, as amended, adjusted as follows:
- 21 a. Reduced by interest income from obligations of the United States and income
22 exempt from state income tax under federal statute or United States or North
23 Dakota constitutional provisions.
- 24 b. Reduced by the portion of a distribution from a qualified investment fund
25 described in section 57-38-01 which is attributable to investments by the qualified
26 investment fund in obligations of the United States, obligations of North Dakota or
27 its political subdivisions, and any other obligation the interest from which is
28 exempt from state income tax under federal statute or United States or North
29 Dakota constitutional provisions.

- 1 c. Reduced by the amount equal to the earnings that are passed through to a
2 taxpayer in connection with an allocation and apportionment to North Dakota
3 under section 57-38-01.35.
- 4 d. Reduced by forty percent of:
- 5 (1) The excess of the taxpayer's net long-term capital gain for the taxable year
6 over the net short-term capital loss for that year, as computed for purposes
7 of the Internal Revenue Code of 1986, as amended. The adjustment
8 provided by this subdivision is allowed only to the extent the net long-term
9 capital gain is allocated to this state.
- 10 (2) Qualified dividends as defined under Internal Revenue Code section 1(h)
11 (11), added by section 302(a) of the Jobs and Growth Tax Relief
12 Reconciliation Act of 2003 [Pub. L. 108-27; 117 Stat. 752; 2 U.S.C. 963
13 et seq.], but only if taxed at a federal income tax rate that is lower than the
14 regular federal income tax rates applicable to ordinary income. If, for any
15 taxable year, qualified dividends are taxed at the regular federal income tax
16 rates applicable to ordinary income, the reduction allowed under this
17 subdivision is equal to thirty percent of all dividends included in federal
18 taxable income. The adjustment provided by this subdivision is allowed only
19 to the extent the qualified dividend income is allocated to this state.
- 20 e. Increased by the amount of a lump sum distribution for which income averaging
21 was elected under section 402 of the Internal Revenue Code of 1986 [26 U.S.C.
22 402], as amended. This adjustment does not apply if the taxpayer received the
23 lump sum distribution while a nonresident of this state and the distribution is
24 exempt from taxation by this state under federal law.
- 25 f. Increased by an amount equal to the losses that are passed through to a
26 taxpayer in connection with an allocation and apportionment to North Dakota
27 under section 57-38-01.35.
- 28 g. Reduced by the amount of military pay received by a taxpayer as a member of
29 the armed forces of the United States on federal active duty, member of the
30 national guard or reserve member of the armed forces of the United States, to
31 the extent that military pay is included in North Dakota taxable income of the

- 1 taxpayer. For purposes of this subdivision, "military pay" includes all federal pay
2 for training, education, mobilization, and bonuses and state pay when called to
3 support an emergency on state active duty.
- 4 h. Reduced by income from a new and expanding business exempt from state
5 income tax under section 40-57.1-04.
- 6 ~~i. Reduced by interest and income from bonds issued under chapter 11-37.~~
- 7 ~~j.~~ Reduced by up to ten thousand dollars of qualified expenses that are related to a
8 donation by a taxpayer or a taxpayer's dependent, while living, of one or more
9 human organs to another human being for human organ transplantation. A
10 taxpayer may claim the reduction in this subdivision only once for each instance
11 of organ donation during the taxable year in which the human organ donation and
12 the human organ transplantation occurs but if qualified expenses are incurred in
13 more than one taxable year, the reduction for those expenses must be claimed in
14 the year in which the expenses are incurred. For purposes of this subdivision:
- 15 (1) "Human organ transplantation" means the medical procedure by which
16 transfer of a human organ is made from the body of one person to the body
17 of another person.
- 18 (2) "Organ" means all or part of an individual's liver, pancreas, kidney, intestine,
19 lung, or bone marrow.
- 20 (3) "Qualified expenses" means lost wages not compensated by sick pay and
21 unreimbursed medical expenses as defined for federal income tax
22 purposes, to the extent not deducted in computing federal taxable income,
23 whether or not the taxpayer itemizes federal income tax deductions.
- 24 ~~k-j.~~ Increased by the amount of the contribution upon which the credit under section
25 57-38-01.21 is computed, but only to the extent that the contribution reduced
26 federal taxable income.
- 27 ~~l-k.~~ Reduced by the amount of any payment received by a veteran or beneficiary of a
28 veteran under section 37-28-03 or 37-28-04.
- 29 ~~m-l.~~ Reduced by the amount received by a taxpayer that was paid by an employer
30 under paragraph 4 of subdivision a of subsection 2 of section 57-38-01.25 to hire
31 the taxpayer for a hard-to-fill position under section 57-38-01.25, but only to the

1 extent the amount received by the taxpayer is included in federal taxable income.
2 The reduction applies only if the employer is entitled to the credit under section
3 57-38-01.25. The taxpayer must attach a statement from the employer in which
4 the employer certifies that the employer is entitled to the credit under section
5 57-38-01.25 and which specifically identified the type of payment and the amount
6 of the exemption under this section.

7 n.m. Reduced by the amount up to a maximum of five thousand dollars, or ten
8 thousand dollars if a joint return is filed, for contributions made under a higher
9 education savings plan administered by the Bank of North Dakota, pursuant to
10 section 6-09-38.

11 e.n. Reduced by the amount of income of a taxpayer, who resides anywhere within
12 the exterior boundaries of a reservation situated in this state or situated both in
13 this state and in an adjoining state and who is an enrolled member of a federally
14 recognized Indian tribe, from activities or sources anywhere within the exterior
15 boundaries of a reservation situated in this state or both situated in this state and
16 in an adjoining state.

17 p.o. For married individuals filing jointly, reduced by an amount equal to the excess of
18 the recomputed itemized deductions or standard deduction over the amount of
19 the itemized deductions or standard deduction deducted in computing federal
20 taxable income. For purposes of this subdivision, "itemized deductions or
21 standard deduction" means the amount under section 63 of the Internal Revenue
22 Code that the married individuals deducted in computing their federal taxable
23 income and "recomputed itemized deductions or standard deduction" means an
24 amount determined by computing the itemized deductions or standard deduction
25 in a manner that replaces the basic standard deduction under section 63(c)(2) of
26 the Internal Revenue Code for married individuals filing jointly with an amount
27 equal to double the amount of the basic standard deduction under section 63(c)
28 (2) of the Internal Revenue Code for a single individual other than a head of
29 household and surviving spouse. If the married individuals elected under
30 section 63(e) of the Internal Revenue Code to deduct itemized deductions in

5 taxable year 2018, for each birth resulting in stillbirth, as defined in section
6 23-02.1-01, for which a fetal death certificate has been filed under section
7 23-02.1-20. For taxable years beginning after December 31, 2018, the deduction
8 amount must be adjusted annually on January first of each year by the
9 cost-of-living adjustment. For purposes of this subdivision, "cost-of-living
10 adjustment" means the percentage increase in the consumer price index for all

26 u.t. Reduced by the amount of retired law enforcement personnel benefits received
27 by a taxpayer who has served a combined total of at least twenty years as a
28 peace officer or has medically retired from the taxpayer's duties as a peace
29 officer with a medical certificate due to a permanent mental or physical disability
30 that rendered the taxpayer unable to discharge the taxpayer's duties as a peace

1 officer, but only to the extent the amount was included in federal taxable income.

2 For purposes of this subdivision:

3 (1) "Peace officer" means a public servant authorized by law or by a
4 government agency or branch of the United States, a state, or a political
5 subdivision of a state to enforce the law and to conduct or engage in
6 investigations of violations of the law.

7 (2) "Retired law enforcement personnel benefits" means retirement income
8 received by a taxpayer eligible to receive retirement income attributable to
9 the taxpayer's employment as a peace officer from a retirement plan
10 maintained by or through the employer from which the taxpayer retired as a
11 peace officer.

12 **SECTION 13. AMENDMENT.** Subsection 1 of section 57-40.5-03 of the North Dakota
13 Century Code is amended and reenacted as follows:

14 1. Aircraft acquired by disabled veterans as defined by the provisions of Public Law
15 No. 79-663 [38 U.S.C. ~~4904~~3901]. This exemption shall be allowed only with respect
16 to one aircraft owned by any disabled veteran.

17 **SECTION 14. REPEAL.** Sections 1-01-18, 1-01-20, 1-01-21, 1-01-27, 1-01-29, 1-01-30,
18 1-01-36, 1-01-40, 1-01-41, 1-01-42, 1-01-45, 1-01-46, 1-01-47, and 1-01-51 of the North Dakota
19 Century Code are repealed.

20 **SECTION 15. EFFECTIVE DATE.** Sections 11 and 12 of this Act are effective for taxable
21 years beginning after December 31, 2024.
