- 1 A BILL for an Act to create and enact a new section to chapter 34-05 of the North Dakota
- 2 Century Code, relating to the creation of the division of apprenticeship within the department of
- 3 labor and human rights; to provide an appropriation; and to provide a report.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** A new section to chapter 34-05 of the North Dakota Century Code is created

6 and enacted as follows:

7 Division of apprenticeship - Duties.

8 <u>1.</u> There is created a division of apprenticeship within the department of labor and human
9 rights.

10 <u>2.</u> <u>Employees of the division of apprenticeship shall report to the labor commissioner.</u>

- 11 <u>3.</u> <u>The labor commissioner may appoint a division director to oversee the division. If the</u>
- 12 <u>labor commissioner appoints a division director, all employees shall report to the</u>
- 13 <u>division director and the division director shall report to the labor commissioner.</u>
- 14 <u>4.</u> <u>The division of apprenticeship:</u>
- 15a.Shall assist, coordinate, and collaborate with the state director from the office of16apprenticeship of the United States department of labor to administer the federal17apprenticeship system within the state.

18 b. Shall develop and implement a statewide strategy to support the state director

- 19 from the office of apprenticeship of the United States department of labor to
- 20 <u>maintain and manage existing apprenticeship programs and develop and expand</u>
 21 <u>newly created apprenticeship programs in the state.</u>
- 22c.Shall develop a pilot program to support a business operating or seeking to23create an apprenticeship program under the federal apprenticeship system.

9	of providing sa	alaries and benefits for the division of apprenticeship staff, for the biennium
10	beginning July	y 1, 2025, and ending June 30, 2027. The department of labor and human rights is
11	authorized thr	ee full-time equivalent positions to administer the division of apprenticeship. The
12	department of	f labor and human rights shall report to the seventieth legislative assembly
13	regarding the	number of apprentices and employers assisted through the division of
14	apprenticeshi	p and the number of new apprenticeship programs created during the 2025-27
15	biennium.
