The department has sufficient appropriation authority but the funding was not specifically appropriated for this purpose.</li> <li>• <b>Attorney General (Request #2144)</b> - The request is to transfer \$250,000 from the capital assets line item to the operating expenses line item to appropriately categorize costs to be incurred for State Crime Laboratory capital improvements.</li> <li>• <b>Department of Environmental Quality (Request #2145)</b> - The request is to transfer \$280,000 of general fund spending authority provided for the licensing and maintenance of a new laboratory information management system from the operating expenses line item to the capital assets line item.</li> <li>• <b>Department of Environmental Quality (Request #2146)</b> - The request is to increase federal funds spending authority by \$313,000 in the capital assets line item to accept and expend federal funding provided for the PM2.5 air monitoring program to improve infrastructure for the existing ambient air monitoring sites and to purchase equipment for a new multipoint air monitoring station to be located in northeastern North Dakota.</li> <li>• <b>Office of Management and Budget (Request #2148)</b> - The request is to increase federal funds spending authority by \$802,000 to accept and expend the Governor's Emergency Education Relief funds for statewide educational needs.</li> </ul>
