19	SECTION 2. LEGISLATIVE INTENT - COST REIMBURSEMENTS - LOAN		
20	<b>REPAYMENTS.</b> It is the intent of the sixty-eighth legislative assembly that the attorney general		
21	seek reimbursement from the federal government for the costs of responding to unlawful activity		
22	associated with the construction of the Dakota access pipeline. It is further the intent of the		
23	sixty-eighth legislative assembly that these reimbursements be used to repay the Bank of North		
24	Dakota loans authorized by the emergency commission and the legislative assembly which		
25	were obtained to provide the funding necessary to respond to the unlawful activity associated		
26	with the construction of the Dakota access pipeline. It is further the intent of the sixty-eighth		
27	legislative assembly that the provisions of section 54-16-13 apply to the loans, except that		
28	emergency commission approval does not apply.
