A BILL for an Act to create and enact a new chapter to title 43 of the North Dakota Century

9 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 23-35-02.2 of the North Dakota Century Code is amended and reenacted as follows:
- 23-35-02.2. Public health units to adoptAdoption of onsite wastewater recycling
 treatment technologies guide Issuance of permit for onsite wastewater treatment
 system installation Inspection Penalty.
 - 1. Each public health unit and board of health shall adopt, administer, and enforce the statewide technical guide for onsite wastewater recycling treatment technologies and sewage distribution technologies established by the onsite wastewater recycling technical committee board.
 - In accordance with the statewide technical guide for onsite wastewater recycling
 treatment technologies, a public health unit or board of health shall issue a permit for
 installation of an onsite wastewater treatment system.
- 3. A person may not install an onsite wastewater treatment system without a permit
 issued under this section. If the public health unit or board of health denies a permit

- under this section, the denial must be in writing and accompanied by findings of fact
 supporting the decision to deny the permit.
- 4. A public health unit and board of health may inspect a newly constructed onsite
 wastewater treatment system. If, upon inspection the public health unit or board of
 health determines any part of the system is not constructed in accordance with the
 minimum standards of the statewide technical guide, the permit applicant or installer,
 or both, shall correct the defects. A system may not be placed in service until all
 defects have been corrected.
 - 5. A public health unit and board of health shall receive and investigate a report of unsanitary conditions in existence at an onsite wastewater system site or that any construction or work enforced under this section is dangerous; unsafe; unsanitary; a nuisance; a risk to life, health, or property; or otherwise in violation of the statewide technical guide.
- 14 6. The public health unit or board of health may charge a fee for issuance of a permit,
 15 conducting an inspection, reviewing a plan, evaluating a site, filing a variance request,
 16 and filing an appeal under this section.
- 7. <u>Violation of the statewide technical guide for onsite wastewater recycling treatment</u>
 technologies is an infraction for each violation.
- SECTION 2. AMENDMENT. Section 43-18.2-01 of the North Dakota Century Code is amended and reenacted as follows:
- 21 **43-18.2-01. Definitions.**
- In this chapter, unless the context or subject matter otherwise requires:
- 1. "Board" means the state board of plumbing.
- 2. "Sewer and water contractor" means any person who installs, plans, and manages the installation and repair of building sewer and water service.
- 3. "Sewer and water installation" means the installation of building sewer and water
 service and the repair of existing building sewer and water service.
- "Sewer and water installer" means any person, other than a sewer and water
 contractor, who installs and repairs building sewer and water service.
- 30 <u>5.</u> "Sewer and water service" does not include installing an onsite wastewater treatment
 31 <u>system.</u>

	c. One representative from the department of environmental quality as appointed by

18	Beginning January 1, 2025, a person may not engage in installing an onsite wastewater				
19	treatment system unless licensed by the board. A violation of this section is an infraction.				
20	Exemptions.				
21	The board shall establish by rule exemptions to the licensure requirements of this chapter				
22	which address installations for new construction. The rules adopted under this section may				
23	distinguish between the type of system being installed and may require a property owner to				
24	attend a	boar	d-approved training as a condition to perform the work.		
25	<u>Licensure - Fees.</u>				
26	<u>The</u>	boar	d shall issue the following licenses to a qualified applicant who pays the required

1 A level one installer license, which qualifies the licensee to install a septic tank and 2 conventional trench system. The fee for licensure and license renewal as a level one 3 installer is two hundred twenty-five dollars per year. 4 3. A level two installer license, which qualifies the licensee to install multiple tanks, 5 mounds, at-grades, beds, and pressurized systems with pumps. The fee for licensure 6 and license renewal as a level two installer is two hundred twenty-five dollars per year. 7 A level three master level installer license, which qualifies the licensee to install 8 commercial systems, industrial systems, and systems that accept more than two 9 thousand five hundred gallons [9463.53 liters] per day. The fee for licensure and 10 license renewal as a level three master level installer is two hundred twenty-five 11 dollars per year. 12 Licensure of out-of-state installers. 13 The board shall issue a license to an applicant who is licensed as an installer by an out-of-14 state jurisdiction if the applicant is in good standing in the out-of-state jurisdiction. 15 Regulatory authority. 16 A licensed installer shall comply with the statewide technical guide for onsite wastewater 17 recycling treatment technologies adopted by the regulatory authority when installing an onsite 18 wastewater treatment system. 19 Disciplinary actions. 20 Installation of an onsite wastewater treatment system by a licensee in violation of this 21 chapter or rules adopted by the board is cause for revocation of, suspension of, or refusal to 22 renew a license. Disciplinary actions must be conducted in accordance with chapter 28-32. 23 Statewide technical guide. 24 <u>1.</u> The board shall develop and publish a statewide guide for onsite wastewater recycling 25 treatment technologies for adoption by regulatory authorities under section 23-35-02.2. 26 At a minimum, the statewide technical guide for onsite wastewater recycling treatment <u>2.</u> 27 technologies must address: 28 A standardized onsite wastewater treatment system permit form. a. 29 The length of time a permit is valid following issuance. b. 30 Circumstances under which a registered professional engineer shall prepare <u>C.</u>

plans and specifications.
