4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1.** A new section to chapter 54-60 of the North Dakota Century Code is created and enacted as follows:
- 7 Regional livestock development and planning program Grants.
- The commissioner shall administer a grant program to assist counties and regional
 planning councils, as defined in chapter 54-40.1, for livestock development planning. A
 county or a regional planning council may submit an application for assistance under
 this section to the commissioner.
 - 2. The commissioner shall award grants to counties and regional planning councils for purposes of coordinating strategic planning and accommodating and encouraging investment in livestock production. Grants shall be awarded for the following activities:
 - a. Identification of suitable locations for rural economic development, including confined animal feeding operations, agricultural processing and storage facilities, and other agricultural-related development. The following factors must be considered when identifying suitable locations for rural economic development:
 - (1) Local zoning and land use regulations;
- 20 (2) State permitting requirements; and
- 21 (3) Availability of infrastructure and natural resources necessary to
 22 accommodate rural economic development projects.
- b. Review and updating of township zoning and land use regulations.

0	out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum		
11	of \$1,210,000, or so much of the sum as may be necessary, to the department of commerce for		
2	the purpose of identifying locations for rural economic development, including confined animal		
3	feeding operations, agricultural processing and storage facilities, and other agricultural-related		
4	development, and assisting the review and updating of township zoning and land use		
5	regulations, for the biennium beginning July 1, 2023, and ending June 30, 2025.
