this bill relates to alcoholic beverage establishment requirements, the authority of the Attorney General to impose fines, the maximum number of gaming sites and pull tab devices allowed, and provides for a modification of allowable expense limits and rent limits for electronic pull tab devices.

Section 4: The gaming system will need to recognize a 60% allocation to an organization whose adjusted gross proceeds per quarter is more than \$100,000 and be able to recognize and allot a 63% allocation to an organization whose adjusted gross proceeds is equal to or less than one hundred thousand dollars.

The gaming division will need one additional investigator for every 30 new sites that are given an 'on sale' liquor license. During the 2023-25 biennium we are estimating at least 30 new sites.

Revenue for the additional sites/devices is estimated at \$2,334,000 for the 2023-25 biennium.

Section 4: The gaming system will need to recognize a 60% allocation to an organization whose adjusted gross proceeds per quarter is more than \$100,000 and be able to recognize and allot a 63% allocation to an organization whose adjusted gross proceeds is equal to or less than one hundred thousand dollars. The cost to upgrade the gaming system to allow for these changes is estimated at \$36,000.

The gaming division will need one additional investigator for every 30 new sites that are given an 'on sale' liquor license. During the 2023-25 biennium we are estimating at least 30 new sites. The cost for an investigator is \$341,283 for salaries and benefits, operating expenses and a vehicle with radios.
