## **SENATE BILL NO. 2108**

- 1 A BILL for an Act to amend and reenact subsection 7 of section 55-08-05,
- 2 subsections <u>3 and 4</u> of section 55-08-06, and subsection 1 of section 55-08-07 of the
- 3 North Dakota Century Code, relating to motor vehicle permit fees; and to repeal section
- 4 <u>55-08-14.1 of the North Dakota Century Code, relating to leadership and facility grants.</u>

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1. AMENDMENT.** Subsection 7 of section 55-08-05 of the North Dakota Century 7 Code is amended and reenacted as follows: 8 7. Charge and collect motor vehicle permit fees in the amounts prescribed by the 9 legislative assembly, which fees are and must be imposed for the sole purposes of 10 paying capital costs of projects required to provide the special services herein 11 described and referred to, and of meeting the principal and interest and reserve-12 requirements of bonds issued to finance such projectsas established under section-13 <del>55-08-06.</del> 14 SECTION 1. AMENDMENT. Section 55-08-05 of the North Dakota Century Code is 15 amended and reenacted as follows: 16 55-08-05. Charges for services. 17 The director may provide special services within state parks, state campgrounds, state 18 recreation areas, and reserves; provide special technical assistance services; and make rules 19 for the use of those services. The director shall establish and cause to be collected charges, 20 fees, and rentals for the use of all special services<del>, and shall revise the same, when necessary,</del> 21 in the manner that the revenue derived will be sufficient to pay the cost of providing each 22 service and to pay the principal of and interest on all bonds issued for projects furnishing the 23 facilities for the services, and to maintain a reserve for the security of the bonds. The director 24 may waive the collection of charges, fees, and rentals for the use of special services by healthSixty-eighth Legislative Assembly

1	care-related charitable organizations conducting group camp activities without charge to-				
2	participants. However, the director shall waive the collection of charges, fees, and rentals for the-				
3	use of all special services by any care-related charitable organization sponsoring or conducting-				
4	summer group camp activities without charge for fourteen days for children from age eight				
5	through age fourteen who have diabetes. Nothing in this section requires the director to provide				
6	camp services if the camp facilities are otherwise closed due to adverse administrative or fiscal-				
7	impacts upon the department. Specifically, the director may:				
8	1.	Provide special parking space for automobiles or other motor-driven vehicles in any			
9		state park or state recreation area.			
10	2.	Provide special parking spurs and campgrounds for automobiles and sites for tent			
11		camping and special auto trailer coach parking spaces for the use of the individual			
12		charged for the space according to the daily rate which must be determined and fixed			
13		by the director consistent with the type of facility provided for the accommodation of			
14		visitors in any particular park and with similar facilities offered for tourist camping in the			
15		area.			
16	3.	Charge a fee for entrance to any pageant grounds created in any state park, state-			
17		recreation area, or reserve for the purpose of having historical or other pageants-			
18		conducted by the agent of any authorized agency.			
19	4.	-Provide water, sewer, and electric service to trailer or tent campsites and buildings and			
20		structures included in projects authorized by the legislative assembly.			
21	<del>5.<u>4.</u></del>	Provide facilities and allow for the sale to the public of food, nonintoxicating			
22		beverages, beer and wine as provided in subsection 6, and other merchandise and			
23		personal services of a suitable nature, and make buildings, structures, and other			
24		recreational facilities available for use and occupancy by the public, or contract for the			
25		use of food vendors or the lease of the buildings, structures, and facilities to a			
26		concessionaire to be operated on the terms and compensation basis as the director			
27		determines to be in the best interest of the state. The duration of a concession			
28		agreement may not exceed twenty years. A bond must be required of each			
29	concessionaire in the amount the director determines, conditioned upon the faithful				
30		performance of all duties under the lease and proper accounting for all funds.

5	SE	CTION 3. AMENDMENT. Subsection 4 of section 55-08-06 of the North Dakota Century				
6	Code is amended and reenacted as follows:					
7	4.	The fees collected must be deposited in the state park operating fund in the state				
8		treasury, unless authorized by the director as follows:				
9		a. The director may allow other agencies or organizations that have leased state				
10		parks, state recreational areas, reserves, or facilities to retain entrance and				
11		special permit fees collected by the lessee.				
12		b. The director may exempt all or any part of any state park, state recreational area,				
13		or reserve from the requirement of the motor vehicle permit and fee, for any				
14		activity or period, when in the director's judgment it is desirable to do so <del>;</del>				
15		provided, however, that no further exceptions may be made after state park-				
16		revenue bonds are issued and while the bonds are outstanding.				
17	SECTION 4. AMENDMENT. Subsection 1 of section 55-08-07 of the North Dakota Century					
18	Code is amended and reenacted as follows:					
19	1.	To pay the current cost of furnishing each special service provided in accordance with				
20		this chapter. For this purpose the charges, fees, and rentals for each service must be				
21		credited to a special operating account, from which must be paid only the current,				
22		reasonable, and necessary cost of operating that service, determined in accordance				
23		with accepted accounting practice, including the purchase price of merchandise and				
24		utilities sold and the compensation of employees necessarily attributable to the				
25		furnishing of that service. The director may incur no operating cost for any building,				
26		structure, or facility leased, and the leases must provide for the payment of the costs				
27		by the lessee and for the payment of a net rental in addition to the costs. No lease				
28		rentals and no motor vehicle permit fees may be credited to operating accounts.
