The bill updates the definition of "purchase price" for the total amount paid for a motor vehicle to exclude any charges or fees for auction services.

If any charges or fees from auction services are currently included in the motor vehicle purchase price, then this exclusion would cause a reduction in revenue to the state general fund and the state aid distribution fund.

The North Dakota Office of State Tax Commissioner does not track vehicle purchase origination. Contact was made with the North Dakota Department of Transportation, and it was confirmed that they also do not track if the vehicle purchase was made at an auction.

Because it is unknown how many vehicle purchases include charges or fees for auction services, the fiscal impact of this bill cannot be determined.
