# 3 - Bill and Fiscal Impact Summary

HB 1504 is related to an alcoholic beverage tax credit for qualified microbrew pubs and brewer taproom licensees for barley purchases and an income tax credit for qualified brewers for barley purchases.

## 4 - Fiscal Impact Sections Detail

Section 1 of HB 1504 creates a North Dakota barley tax credit for a microbrew pub or brewer taproom licensee that produces beer and purchases more than 40% of the licensee's total annual barley purchases from a farmer or supplier in this state. The tax credit can be applied against the alcoholic beverage tax liability and is equal to 15% of the amount to tax imposed on beer sold by the microbrew pub or brewer taproom licensee to wholesalers annually in this state.

Section 2 of HB 1504 creates a North Dakota barley tax credit for a brewer that produces beer and purchases more than 40% of the brewer's total annual barley purchases from a farmer or supplier in this state. The tax credit can be applied against the income tax liability and is equal to 15% of the amount to tax imposed on beer sold by the microbrew pub or brewer taproom licensee to wholesalers annually in this state. The credit cannot exceed the taxpayer's income tax liability. Any credit amount exceeding the income tax liability for the taxable year may not be claimed as a carryback or carryforward.

Section 3 of HB 1504 makes this act effective for the first two taxable years beginning after 12/31/2022.

#### 5 - Revenues Detail

If enacted, section 1 of HB 1504 will create a reduction in revenue to the general fund. If all licensed microbrew pubs and brewer taproom claim the tax credit, this reduction in revenue is estimated to be approximately \$6 thousand in the 2023-2025 biennium.

If enacted, sections 2 and 3 of HB 1504 will create a reduction in revenue to the general fund. The reduction in revenue is dependent on several undetermined factors. This includes the number of taxpayers who choose to claim the credit, the amount of barley purchased, and finally, what the taxpayers' liabilities are. Due to these factors, the Office of State Tax Commissioner is unable to provide a reliable estimate for this revenue reduction amount.
