SB2094 relates to the expansion of the national guard tuition grants to include out-of-state postsecondary education institutions.

## 4 - Fiscal Impact Sections Detail

Section 1 of SB 2094 would have a fiscal impact as this relates to the expansion of the national guard tuition grants to include out-of-state postsecondary education institutions that are not currently eligible for the tuition program.

The fiscal note includes assumptions based on the number of current Servicemembers attending out-of-state institutions (projected 60 members), as well as potential recruits to the national guard (projected 25 members) who

would potentially utilize the program. The calculations were made off the highest North Dakota tuition rate allowed of \$9,500.

The tuition program is supported with 100% general funds in the agency's Tuition, Recruiting, and Retention budget line. The expenditures are projected to be \$1,615,000 for a full biennium. The agency is anticipating \$1,700,000 of tuition carryover dollars from the 2021-2023 biennium that could be utilized for this purpose. If carryover dollars were utilized, no additional funds would be needed for the 2023-2025 biennium.

No FTE positions would be affected.
