SB 2033 creates a distressed ambulance service program.

Section 1 of SB 2033 creates a distressed ambulance service program. A distressed ambulance service is one that has self-indicated to the department a substantial likelihood of closure within the next year or been identified by the department as noncompliant with federal or state laws or regulations and is likely to face closure within the next year.

To be able to administer this service, the Department estimates the operating expenses would be \$7,056 for the

2025-2027 biennium.

The Department would need general fund dollars for travel and advertising costs.

Section 2 declares this to be an emergency measure.
