HB 1214 changes the transportation payment calculation for school districts. The formula would include factors of square miles of the district, number of runs, and number of buildings in the district. The formula would no longer use rides as a factor.

Section 1 provides the calculation to convert the transportation information into a weighted student unit to calculate the transportation funding. The weighted student units are multiplied by the per pupil payment set in subsection 3 of section 15.1-27-04.1. Transportation funding would increase as the per pupil payment increases. NDDPI is using 2023-24 miles, runs, district square miles, and number of buildings for purposes of calculating this fiscal note.

Using the 2023-2024 transportation report, school buildings, and district square mileage, the increase in transportation funding would be approximately \$10 million for the 2025-2027 biennium.

The fiscal note of this bill would increase with increases to the per pupil payment. The fiscal note assumes a per pupil payment of \$11,072. HB 1369 has a 3% & 3% increase to the per pupil payment. If HB 1369 passes, that would increase the fiscal note for HB 1214 to \$12.6 million.

The appropriation for school district transportation is in HB 1013. The 2023-2025 appropriation is \$58.1 million. The new appropriation request would be \$61 million as not all \$58.1 million will be spent in the 2023-2025 biennium.
