- 1 A BILL for an Act to amend and reenact sections 4.1-01.1-07 and 4.1-01.1-08 of the North
- 2 Dakota Century Code, relating to uses of the agriculture diversification and development fund
- 3 and committee; to provide an appropriation; and to provide for a transfer.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 SECTION 1. AMENDMENT. Section 4.1-01.1-07 of the North Dakota Century Code is
- 6 amended and reenacted as follows:

7 4.1-01.1-07. Agriculture diversification and development fund - Continuing

8 appropriation.

- 9 1. There is created in the state treasury the agriculture diversification and development 10 fund. The fund consists of all moneys transferred to the fund by the legislative 11 assembly, interest upon moneys in the fund, and payments of interest and principal on 12 loans made from the fund. Moneys in the fund are appropriated to the Bank of North 13 Dakota on a continuing basis for loan disbursements and administrative costs 14 pursuant to this section, and moneys in the fund are appropriated to the agriculture 15 commissioner on a continuing basis for grants pursuant to this section and section 16 4.1-01-27. The agriculture diversification and development committee shall designate 17 the amount available from the fund for loans, interest rate buydowns, and grants. 18 Loans, interest rate buydowns, or grants under subsections 3 and 4 may be issued 2. 19 from the fund to support new or expanding value-added agriculture businesses that 20 demonstrate financial feasibility, enhance profitability for farmers and ranchers, create
- 21 jobs, and grow the state's economy. Grants under section 4.1-01-27 may be issued
- from the fund for infrastructure improvements necessary for the development or

1		expansion of new or existing value-added agriculture businesses. Value-added	
2		agriculture businesses include food production or processing facilities; feed or pet food	
3		processing facilities; commodity processing facilities; agriculture product	
4		manufacturers; and animal agriculture production facilities, including swine, poultry,	
5		dairy, and feed lot production facilities.	
6	3.	The Bank of North Dakota shall develop policies for loans and interest rate buydowns	
7		from the fund in consultation with the agriculture diversification and development	
8		committee. The Bank shall review loan applications. To be eligible for a loan under this	
9		section, an entity shall agree to provide the Bank with information as requested. The	
10		Bank may develop policies for loan participation with local financial institutions. The	
11		Bank shall deposit in the fund all principal and interest paid on the outstanding loans.	
12		The Bank may use a portion of the interest paid as a servicing fee to pay for	
13		administrative costs, which may not exceed one-half of one percent of the amount of	
14		the outstanding loans. The fund must be audited annually pursuant to section 6-09-29,	
15		and the cost of the audit must be paid from the fund.	
16	4.	The agricultural diversification and development committee shall develop policies for	
17		grants from the fund to support new or expanding value-added agriculture businesses,	
18		including eligibility criteria, maximum grant amounts, and reporting requirements.	
19		Based on recommendations from the agricultural diversification and development	
20		committee, the agriculture commissioner shall distribute the grant funding.	
21	<u>5.</u>	The agriculture diversification and development committee may use funding available	
22		in the agriculture diversification and development fund for in-state travel, per diem, and	
23		related costs of administering grants under this section. The agriculture commissioner	
24		may reimburse agriculture diversification and development committee members for	
25		in-state travel, per diem, and related costs incurred associated with the program as	
26		authorized under subsection 2 of section 4.1-01.1-08.	
27	SEC	TION 2. AMENDMENT. Section 4.1-01.1-08 of the North Dakota Century Code is	
28	amended and reenacted as follows:		
29	4.1-0	01.1-08. Agriculture diversification and development committee.	
30	1.	The agriculture diversification and development committee consists of eleven	
31		members, five of whom must be appointed by the commissioner for terms of two years

1		each, arranged so that two terms expire in odd-numbered years and three terms
2		expire in even-numbered years.
3		a. Four of the members appointed by the commissioner must be actively engaged
4		in farming in this state and the fifth member appointed by the commissioner must
5		be actively engaged in agribusiness in this state.
6		b. The governor shall appoint one member for a term of two years which expires in
7		odd-numbered years.
8		c. The member appointed by the governor must be actively engaged in business in
9		this state.
10		d. The remaining committee members must consist of:
11		(1) One representative from the independent community banks of North
12		Dakota;
13		(2) One representative from the North Dakota bankers association;
14		(3) The commissioner of commerce or the commissioner's designee;
15		(4) The president of North Dakota state university or the president's designee;
16		and
17		(5) The agriculture commissioner or the commissioner's designee.
18		e. The committee shall elect one of its members as chairman.
19	2.	The agriculture diversification and development committee shall develop guidelines for
20		the grants, including eligibility criteria and reporting requirements. The guidelines must
21		include priority for businesses with a majority of the ownership comprised of North
22		Dakota residents. The agriculture diversification and development committee shall
23		review grant applications and make funding determinations. Members of the
24		committee are entitled to be reimbursed for expenses incurred in the performance of
25		their duties, in the same manner as other state officials are reimbursed, in accordance
26		with sections 44-08-04 and 54-06-09. If not otherwise employed by the state of North
27		Dakota, members of the committee are entitled to receive per diem compensation of
28		one hundred thirty-five dollars for each day of attending meetings and performing
29		other duties relating to official business of the committee.
30	SEC	TION 3. APPROPRIATION - TRANSFER TO AGRICULTURE DIVERSIFICATION
31		VELOPMENT FUND. There is appropriated out of any moneys in the general fund in

- 1 the state treasury, not otherwise appropriated, the sum of \$15,000,000, which the office of
- 2 management and budget shall transfer to the agriculture diversification and development fund,
- 3 for the biennium beginning July 1, 2025, and ending June 30, 2027.
