Representative Christy served in the North Dakota House of Representatives from 2022-2025. He held to the ideal of being kind, respectful, and nice to one another. Known as a "Gentle Giant", he selflessly donated his organs leaving a legacy that will live in others.

During Donate Life Month, we honor the compassion and generosity of registered donors and donor families; and we recognize the commitment of dedicated healthcare teams and all those who work tirelessly to save and heal lives through donation and transplantation.

More than 100,000 Americans - over 2,600 in the Upper Midwest region - are currently on the transplant waiting list.

Another person is added to the waiting list every 7.5 minutes.

One person can save up to eight lives through organ donation and heal over seventy-five lives as a tissue and eye donor.

The most effective way to address this health crisis is to educate and to encourage citizens to commit to the following actions: (1) register your decision to be an organ, eye and tissue donor at [Life-Source.org/Register](https://Life-Source.org/Register) or at your local DMV, and (2) make your decision known with your family and friends.
