Engrossed HB 1525 as amended creates a 7-member gaming commission to replace the current five-member commission and gives the new commission more authority over gaming.

The amendment increases the number of commission members from 5 to 7 and increases the daily compensation from \$75 per day per member to an amount provided in NDCC 54-03-20 for legislators, currently \$213 per day but expected to increase to \$219 per day on July 1, 2025, and \$226 on July 1, 2026.

Mileage and expense reimbursement will also be increased due to the increase in the size of the commission.

The amendment also requires all hearings to be recorded on video and broadcast live. The cost of this is unknown.

The full costs of the new commission cannot be determined as it is unknown how many hearings will be held, the length of the hearings, and total expenses incurred by the committee. The commission is required to meet at least quarterly (8 meetings in the 2025-27 biennium). Compensation for these 8 meetings would be \$12,460 plus mileage, hotel, and meal reimbursements. Each additional meeting in the first year of the biennium would cost \$1,533 plus mileage, hotel, and meal reimbursements; and \$1,582 plus mileage, hotel, and meal reimbursement in the second year.

If the committee were to meet every month the compensation for 24 months would be \$37,380 plus mileage, hotel, and meal reimbursements.

The Attorney General has \$7,849 budgeted for the current gaming commission. This bill, as amended, includes a \$25,000 one-time appropriation for the gaming commission, for a total of \$32,849. It is unknown if this amount is sufficient to cover the new commission costs for a biennium.
