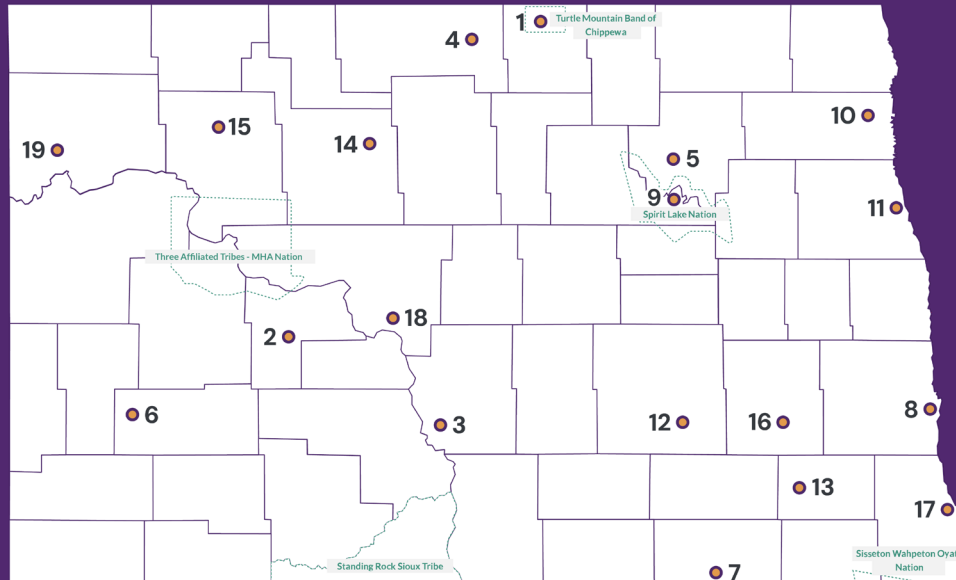
Chairman Nelson and the Members of the Committee, my name is Seth O'Neill, and I represent the North Dakota Domestic & Sexual Violence Coalition, in support of SB2015.

SB2015 includes \$7 million for supplemental funding for crime victim services due to the decline in the federal Victims of Crime Act (VOCA) funding. The member organizations of the North Dakota Domestic & Sexual Violence Coalition rely on VOCA funding to provide important services to victims of domestic and sexual violence. Attached to my written testimony, I have provided letters from a few of these programs discussing the need for this funding.

Chairman Nelson, we encourage the committee to give SB2015 a "Do-Pass" recommendation with the \$7 million for crime victim services. I look forward to testifying at a future public hearing to explain more how essential these services are. Thank You.

Chairman Nelson and members of the House Appropriations Committee, my name is Gloria Olheiser and I am the Director of Women's Action and Resource Center. Our organization is a member of the North Dakota Domestic & Sexual Violence Coalition.

I am writing in support of the VOCA supplemental funding included in SB2015 for victim services grants. Women's Action & Resource Center (WARC) provides services for Mercer, Oliver & the eastern quarter of Dunn Counties. Our services include but are not limited to 24/7 crisis line, emergency shelter, information and referrals, advocacy for judicial, employment, housing, medical as well as counseling services, crisis intervention, information & referrals & food pantry. We assist victims of domestic violence, sexual assault, human trafficking, dating violence, family violence, elder abuse, stalking and more.

The VOCA dollars we get in our grant assists us to continue to provide these services as the need continues to grow. The VOCA grant provides dollars for emergency services such as rent, utilities (past due/shut off notices), deposit, 1<sup>st</sup> months rent up to 3 months rent IF needed. In addition, the grant does pay for part of the advocates wages along with shelter supervisors in our emergency shelter along with overtime or shift differential, fringe, counseling. Our phone bill, public presentation materials and travel and professional development for advocates to attend trainings with EVAWI, CCAW, Alliance for Hope and more so they may better advocate for our victims and assist them to the best of our ability. To lose part of or all of the dollars in this grant or any grant would be very devastating to our service area as the need continues to grow from year to year.

Chairman Nelson and members of the House Appropriations Committee, my name is Liz Anderson, and I am the Executive Director of The Abuse Resource Network & Therapy. Our organization is a member of the North Dakota Domestic & Sexual Violence Coalition.

I am writing in support of the VOCA supplemental funding included in SB2015 for victim services grants. Our agency uses VOCA (Victims of Crime Act) funding to provide essential services to survivors of domestic violence and sexual assault. Specifically, the VOCA funding helps cover the cost of direct services, such as addiction counseling and therapy for survivors, legal advocacy, case management, and crisis intervention. This funding allows us to offer these services free of charge, ensuring that anyone in need can access support regardless of their financial situation. With our agency being 180 miles round trip to the nearest mental health services, this funding is crucial in assisting providing these services. VOCA funds also support the training and salaries of our dedicated staff, helping us maintain a highly trained team equipped to handle the complex needs of survivors.

The supplemental state funding is crucial to bridging the gap between the VOCA funding and the growing demands of our services. It helps us address immediate, urgent needs, such as emergency shelter, food, transportation, and legal assistance, which are not always fully covered by VOCA funds. Without the state supplemental funding, our agency would be forced to scale back services, leading to longer waiting times for therapy and other critical services. In the worst-case scenario, we may need to reduce staffing or cut certain programs, which could result in survivors not receiving the comprehensive support they need in a timely manner.

Therefore, supplemental state funding is vital to ensure that our agency can continue to offer holistic, responsive care to all survivors in need.

Chairman Nelson and members of the House Appropriations Committee, my name is Laura Nash Frisch and I am the Vice President of Victim Witness and Visitation at the Community Violence Intervention Center (CVIC) in Grand Forks, ND. Our organization is a member of the North Dakota Domestic & Sexual Violence Coalition.

**I am writing in support of the Victims of Crime Act (VOCA) supplemental funding included in SB 2015 for victim services grants.** These funds provide critical services to victims of crime in our community, funding three direct service areas, crisis advocacy, therapy, and crime victim witness services. Up until the 2024-2025 federal fiscal year, VOCA represented more than \$750,000 of our annual operating revenue, and has been a steady source of funding for decades. Due to decreases in the fund at the federal level, our VOCA award this year was just under \$517,000, a 37% decrease over the previous year.

**Without state intervention, the impact on crime victims would be devastating.** VOCA funds are used almost exclusively to serve victims, so a reduction at this level would leave victims with fewer options to turn to for help. Victims would be met with waiting lists for services like therapy, delayed crisis intervention response to urgent calls from law enforcement, medical partners, and schools, limited assistance with civil protection orders, and reduced security and staffing at our 24-hour emergency shelter. In short, nearly every service currently available to victims at our agency would be negatively impacted.





Additionally, VOCA is a key source of funding for victim witness services provided alongside the Grand Forks County States Attorney's Office. These services **uphold mandated standards in North Dakota law** found in the Fair Treatment Standards for Victims and Witnesses, NDCC 12.1-34 and Marsy's Law, Article I, Section 25 in the state constitution. Reductions in this program would endanger crime victims who may not receive notice when violent offenders are being released from correctional centers and would place a greater burden on the States Attorney's Office to carry out timely notices of hearings, plea agreements and dispositions, gather victim impact statements, assist with crime victims' compensation and more.

Each year, **CVIC serves over 3,000 victims of crime in the Grand Forks region.** A 37% decrease would impact at least 1,110 of these victims. We urge the committee to vote in favor of the \$7,000,000 allocated to fill the gap left by reductions in the federal VOCA fund. Thank you for your consideration.

VOCA is one of DVRCC's largest grants and provides money for salaries for all 6 of our domestic violence and sexual assault advocates. Without VOCA money, we would have to work with only 5 advocates as we would not have the funding to pay for 6 salaries. Our agency covers 8 counties which include: Adams, Billings, Bowman, Dunn, Golden Valley, Hettinger, Slope and Stark counties. This is a land mass of 10,002 square miles.
