Senate Concurrent Resolution "A", Chapter 362, 1955 Session Laws, proposed by the 34th Legislative Assembly of the state of North Dakota to provide for the amendment of section 93 of the Constitution of the state of North Dakota, relating to publication of supreme court decisions by omitting the words "The legislative assembly shall make provisions for the publication and distribution of the decisions of the supreme court and for the sale of the published volumes thereof.", and inserting the words "The decisions of the supreme court shall be published or recorded in the manner and form prescribed by the legislative assembly."

INDIAN JURISDICTION

Senate Concurrent Resolution "W", Chapter 364, 1955 Session Laws, proposed by the 34th Legislative Assembly of the state of North Dakota to provide for the amendment of paragraph 2 of section 203 of the Constitution of the state of North Dakota, relating to state jurisdiction over lands of the United States and Indian lands by inserting the words "provided, however, that the legislative assembly of the state of North Dakota may, upon such terms and conditions as it shall adopt, provide for the acceptance of such jurisdiction as may be delegated to the state by Act of Congress."
