WISHING REPRESENTATIVE HENSRUD A SPEEDY RECOVERY

A resolution wishing Representative I. O. "Sparky" Hensrud a speedy recovery from his illness.

WHEREAS, Representative "Sparky" Hensrud has served his community and State as a County Sheriff, State Highway Patrolman, and for the past four sessions, a distinguished member of the House of Representatives; and

WHEREAS, he is presently the Chairman of the Transportation Committee of the House of Representatives; and

WHEREAS, he has been hospitalized as the result of a blood clot;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE

That the House of Representatives wishes him a complete and speedy recovery so that he can rejoin his colleagues in the activities of the Forty-third Legislative Assembly; and

BE IT FURTHER RESOLVED, that a committee of three Representatives be appointed by the Speaker of the House of Representatives to personally deliver a signed copy of this resolution to Representative Hensrud.

APPOINTING OFFICIAL PHOTOGRAPHER

A resolution to appoint an official photographer for the House of Representatives of the Forty-third Legislative Assembly of the State of North Dakota.

WHEREAS, for historical purposes it has been the custom of all North Dakota Legislative Assemblies to have composite group pictures made of all members of such assemblies; and

WHEREAS, Manda-Color Studio of Mandan, North Dakota, offers to take six proof color photographs of each Representative, the Clerk of the House, the Assistant House Clerk, the House Bill Clerk, the House Desk Reporter, and the House Sergeant-at-Arms, and to retouch said proofs; to make a composite color picture, size 38 x 49 inches, framed and ready to hang, of the photographs of the aforementioned; to make 107 color copies of said picture, 14 x 11 inches in size, one for each person pictured therein; and to make one 5 x 7 inch color, and one 5 x 7 inch black and white photograph of each Representative; all the foregoing at a cost of \$1,756.00;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NORTH DAKOTA:

That Manda-Color Studio of Mandan, North Dakota, be and is hereby appointed official photographer for the House of Representatives of the Forty-third Legislative Assembly of the State of North Dakota; and

BE IT FURTHER RESOLVED, that the Manda-Color Studio of Mandan, North Dakota, is hereby awarded the sole privilege of photographing members of the House of Representatives and the above-mentioned House employees of the Forty-third Legislative Assembly, at a cost of \$1,756.00 to be charged as a legislative expense; and

BE IT FURTHER RESOLVED, that the photographs shall be delivered on or before June 1, 1973.
