WHEREAS, the Reverend N. E. McCoy of Jamestown is a name and voice familiar to generations of North Dakotans through his radio ministry; and

WHEREAS, through his daily broadcasts the past thirty-eight years, the Reverend McCoy has reached and enriched the homes and lives of thousands of citizens of North Dakota and neighboring states; and

WHEREAS, during his fifty-one distinguished years in the ministry, the Reverend McCoy has demonstrated time and again his concern for the troubled and less fortunate as a sponsor for prisoners on parole, supervising them and helping them secure employment; and

WHEREAS, for the past fifteen years, Reverend McCoy has worked with prisoners within the confines of the North Dakota Penitentiary as the official prison chaplain; and

WHEREAS, over the years, Reverend McCoy has actively worked with American servicemen, having served as chaplain of the North Dakota National Guard during World War II; and

WHEREAS, during his fifty-one years in the ministry and thirty-eight years in the radio ministry, the Reverend McCoy has been recognized for his service to mankind through numerous awards, among them the Jamestown College Distinguished Service Award, the Jamestown Chamber of Commerce Outstanding Citizen Award, and the Sertoma International Service to Mankind Award;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Senate welcomes to its chambers and is honored by the presence of the Chaplain of the Day, the Reverend N. E. McCoy.

#### SENATE RESOLUTION NO. 3

# SELECT COMMITTEE TO STUDY BANK OF NORTH DAKOTA

A resolution creating a select Senate committee to study and review the administration, operation, and investment policies of the Bank of North Dakota, and to report its findings and recommendations to the Senate within thirty legislative days of the passage of this resolution.

WHEREAS, there has not been a recent legislative study and review of the operations and administration of the Bank of North Dakota; and

WHEREAS, recent legislative assemblies have added many areas of responsibility to the overall responsibilities of the Bank; and

WHEREAS, it is a necessary prerequisite to any legislative action concerning policy or appropriations that the Legislative Assembly have as many facts and data as possible on the subject at hand; and

WHEREAS, the Forty-fourth Legislative Assembly is already in session, and such facts and data must be gathered swiftly and put before the Senate if it is to be the basis of action during this session;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the creation of a select Senate study and review committee is hereby authorized. The committee shall be composed of seven members, five from the majority party and two from the minority party, to be appointed by the Floor Leaders of the two parties. The appointments are to be made within two days after passage of this resolution, and the Majority Floor Leader shall appoint the Chairman of the committee. The committee is hereby empowered to study and review the administration and operation of the Bank of North Dakota in all its phases, and the Bank's investment policies. The committee is to report its findings and recommendations to the Senate within thirty legislative days after passage of this resolution; and

BE IT FURTHER RESOLVED, that the select committee created by this resolution may call upon such persons in the employ of

the Bank of North Dakota as it may deem appropriate; and may call upon members of the Industrial Commission, the Legislative Council, the State Treasurer, the State Examiner, and any other executive department, agency, office, officer, board, bureau, commission, or institution, or any organization or individuals outside state government, for any reasonable assistance in the conduct of its study and review as the committee deems necessary; and

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded immediately by the Secretary of State to each member of the Industrial Commission, to the State Examiner, and to the President of the Bank of North Dakota.

### APPOINTING SENATE PHOTOGRAPHER

A resolution to appoint an official photographer for the Senate of the Forty-fourth Legislative Assembly of the state of North Dakota.

WHEREAS, for historical purposes it has been the custom of all North Dakota Legislative Assemblies to have composite group pictures made of all members of such assemblies; and

WHEREAS, Manda-Color Studio of Mandan, North Dakota, offers to take six proof color photographs of each Senator, the Lieutenant Governor, the Secretary of the Senate, the Assistant Senate Secretary, the Senate Bill Clerk, the Senate Desk Reporter, and the Senate Sergeant-at-Arms, and to retouch said proofs; to make a composite color picture, size 30 x 40 inches, framed and ready to hang, of the photographs of the aforementioned; to make 57 color copies of said picture, 14 x 11 inches in size, one for each person pictured therein; and to make one 5 x 7 inch color, and one 5 x 7 black and white, photograph of each Senator and the Lieutenant Governor; all the foregoing at a cost of \$1,070.00;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That Manda-Color Studio of Mandan, North Dakota, be and is hereby appointed official photographer for the Senate of the Forty-fourth Legislative Assembly of the State of North Dakota; and

BE IT FURTHER RESOLVED, that Manda-Color Studio of Mandan, North Dakota, is hereby awarded the sole privilege of photographing members of the Senate and the abovementioned Senate employees of the Forty-fourth Legislative Assembly, at a cost of \$1,070.00 to be charged as a legislative expense; and

BE IT FURTHER RESOLVED, that the photographs shall be delivered on or before June 1, 1975.
