



Other Sections in Bill

Section 4 of House Bill No. 1009 authorizes \$2,725,077 from the **environment and rangeland protection fund** for pesticide programs (\$425,875), Project Safe Send (\$600,371), noxious weed control (\$1,473,831), minor use pesticide projects (\$200,000), and the Crop Protection Product Harmonization and Registration Board (\$25,000). The House increased the total authorization from the environment and rangeland protection fund to \$2,805,077 for pesticide programs (\$425,875), Project Safe Send (\$530,371), noxious weed control (\$1,473,831), the Crop Protection Product Harmonization and Registration Board (\$25,000), saltcedar control (\$250,000), and Agriculture in the Classroom (\$100,000).

Section 5 of House Bill No. 1009 authorizes \$61,410 from the anhydrous ammonia inspection fund for anhydrous ammonia facilities licensing activities.

Section 6 of House Bill No. 1009 authorizes \$700,000 from the **game and fish fund**, \$550,000 for wildlife services and \$150,000 for the Board of Animal Health.

Section 7 of House Bill No. 1009 authorizes a transfer of \$200,000 from the environment and rangeland protection fund to the minor use pesticide fund to continue research to facilitate the registration of new pesticides to be used on crops or for new uses of existing pesticides. Pursuant to North Dakota Century Code Section 4-35-06.3, all money in the minor use pesticide fund are appropriated on a continuing basis to the Crop Protection Product Harmonization and Registration Board.

Section 8 of House Bill No. 1009 provides for general fund revenues generated specifically from **Pride of Dakota** events to be made available to the Agriculture Commissioner's office for the Pride of Dakota program. The executive budget recommendation includes a total general fund appropriation of \$321,997 for the Pride of Dakota program. The House reduced the general fund appropriation for the Pride of Dakota program to \$139,594.

Section 9 of House Bill No. 1009 increases the statutory changes necessary to increase the Agriculture Commissioner's salary as follows:

Annual salary authorized by the 2003 Legislative Assembly:

July 1, 2003 \$69,874

Proposed annual salary recommended in the 2005-07 executive budget:

July 1, 2005 \$72,669

July 1, 2006 \$75,576 (may not exceed)

The executive recommendation provides funding for elected officials' salary increases equal to 4 percent of salaries effective July 1, 2005, and 3 percent effective July 1, 2006. An additional 1 percent may be provided to the extent the increase can be paid with existing agency resources. Section 9 of House Bill No. 1009 provides that the July 1, 2006, increase may not exceed 4 percent.

The House adjusted the Agriculture Commissioner's salary to reflect an increase of 3 percent effective July 1, 2005, and 4 percent effective July 1, 2006.

Section 10 of Engrossed House Bill No. 1009 increases the compensation from \$25 to \$62.50 for supervisors of soil conservation districts for attending meetings or events related to their duties.

Sections 11 and 12 of Engrossed House Bill No. 1009 make statutory changes relating to the duties and responsibilities of the Agriculture in the Classroom Council.

Section 10 of House Bill No. 1009 removes the sunset clause on the biennial \$350 per product pesticide registration fee. Of this amount, \$300 is deposited in the environment and rangeland protection fund and \$50 in the general fund. The fee was to revert to \$300 on June 30, 2005. It is anticipated that the removal of the sunset clause will generate an additional \$475,000 of revenue, or a total of \$2,850,000 to be deposited in the environment and rangeland protection fund (Section 13 of Engrossed House Bill No. 1009).

Major Related Legislation

Senate Bill No. 1093 increases late registration fees for feed retailers and fees for late tonnage reports and establishes a minimum tonnage fee of \$10.

Senate Bill No. 2114 adds a reinspection fee of \$75 for each farm facility inspection conducted beyond the normal inspections for Grade A and manufacturing grade facilities. Such reinspections result from adverse actions such as a farm permit suspension, the downgrade from Grade A to manufacturing grade, or unsanitary conditions that require correction within a specified period of time.

Senate Bill No. 2371 provides that minimum-risk pesticide is exempt from registration.
