

Continuing Appropriations

Custodial funds - NDCC Section 37-15-21 - The Veterans Home may accept gifts, donations, or bequests and any money received must be used for the specific purposes as designated by the donor or grantor.

Major Related Legislation

House Bill No. 1425 - This bill removes the requirement that the Veterans Home spend federal and special funds prior to spending their general fund appropriation.

House Bill No. 1459 - This bill also provides a \$31,200 special funds appropriation to the Veterans Home for extraordinary repairs.
