



### Other Sections in Bill

Section 4 of Engrossed House Bill No. 1020 provides that, in addition to the amount appropriated as other funds, any other income received from federal acts, private grants, gifts, and donations, or from other sources received by the branch research centers is appropriated for the purpose designated in the act, grant, gift, or donation for the 2007-09 biennium.

Section 5 of Engrossed House Bill No. 1020 authorizes the transfer of appropriation authority between the Main Research Center, the branch research centers, NDSU Extension Service, and Northern Crops Institute.

Section 6 of Engrossed House Bill No. 1020 authorizes the State Board of Higher Education to adjust or increase full-time equivalent positions for the branch research centers and report any adjustments to the Office of Management and Budget.

Section 7 of Engrossed House Bill No. 1020 provides that the Agronomy Seed Farm and branch research centers may elect to exempt certain vehicles used in farming operations from state motor pool requirements.

Section 8 of Engrossed House Bill No. 1020 authorizes the carryover of any unexpended general fund appropriation and excess income received by the branch research centers.

Section 11 of Engrossed House Bill No. 1020 provides carryover authority for the North Central Research Center laboratory and greenhouse project. The 2005 Legislative Assembly authorized \$1,690,000 for the project, of which \$440,000 is from bond proceeds and \$1,250,000 is from gifts, grants, and donations.

Section 13 of Engrossed House Bill No. 1020 provides that the Dickinson Research Center waste management facility (\$351,000), headquarters facility parking lot and landscaping (\$350,000), and North Central Research Center agronomy laboratory and greenhouse (\$350,000) projects are an emergency.





Section 4 of Engrossed House Bill No. 1020 provides that, in addition to the amount appropriated as special funds, any other income received from federal acts, private grants, gifts, and donations, or from other sources received by the Main Research Center is appropriated for the purpose designated in the act, grant, gift, or donation for the 2007-09 biennium.

Section 5 of Engrossed House Bill No. 1020 authorizes the transfer of appropriation authority between the Main Research Center, the branch research centers, NDSU Extension Service, and Northern Crops Institute.

Section 6 of Engrossed House Bill No. 1020 authorizes the State Board of Higher Education to adjust or increase full-time equivalent positions for the Main Research Center and report any adjustments to the Office of Management and Budget.

Section 8 of Engrossed House Bill No. 1020 authorizes the carryover of any unexpended general fund appropriation and excess income received by the Main Research Center.

Sections 9 and 10 of Engrossed House Bill No. 1020 provide for a study of industrial hemp and authorizes the Main Research Center to contract with any other university for the procurement of hemp seed necessary to conduct research.

Section 11 of Engrossed House Bill No. 1020 provides carryover authority for the research greenhouse complex at the Main Research Center. The 2005 Legislative Assembly authorized \$7 million for the project, of which \$2 million is from bond proceeds and \$5 million is from gifts, grants, and donations. The Main Research Center may use any funding available within the total appropriation authority of \$14 million to begin construction on the project.

Section 13 of Engrossed House Bill No. 1020 provides that Phase II of the research greenhouse complex (\$7,000,000), Carrington Research Center headquarters office, Hettinger Research Center headquarters office, and North Central Research Center office projects (\$907,750) are an emergency.

## **Continuing Appropriations**

No continuing appropriations for this agency.

## **Major Related Legislation**

House Bill No. 1459 - This bill provides a \$840,465 general fund appropriation to the Main Research Center for extraordinary repairs.

**Senate Bill No. 2288** - This bill provides for a biomass energy center consisting of a multidisciplinary group led by the North Dakota Agricultural Experiment Station and North Dakota State University Extension Service to conduct research and provide education relating to biomass production and conversion. Section 5 of the bill provides that House Bill No. 1020 (2007) includes \$400,000 for the North Dakota Agricultural Experiment Station to support the activities of the perennial biomass production initiative at the biomass energy center.




