


Other Sections in Bill

2009-11 Wildlife Services funding - Section 3 provides \$200,000 from the game and fish fund for additional funding for Wildlife Services during the 2009-11 biennium.

Game and fish funding - Section 6 provides \$1,068,261 from the game and fish operating fund for the State Board of Animal Health (\$199,461) and Wildlife Services (\$868,800) for the 2011-13 biennium. The 2009-11 legislative appropriations from the game and fish fund for these programs were \$968,800.

Agriculture Commissioner's salary - Section 7 includes the statutory changes necessary to increase the commissioner's salary as follows:

Annual salary authorized by the 2009 Legislative Assembly:

July 1, 2009	\$85,830
July 1, 2010	\$90,122

Proposed annual salary recommended in the 2011-13 executive budget:

July 1, 2011	\$92,826	
July 1, 2012	\$95,610	

The executive recommendation provides funding for elected officials' salary increases equal to 3 percent of salaries effective July 1, 2011, and 3 percent effective July 1, 2012.

Sustainable agriculture program - Section 8 amends North Dakota Century Code Section 4-01-23 regarding the sustainable agriculture program.

Wine and spirits promotion - Sections 9 and 10 provide statutory changes to allow special events permits to be issued for wine and spirits promotion in the state.

Fertilizer distribution registration, licensing, and inspection fees - Sections 11, 12, and 13 provide statutory changes to deposit fertilizer distribution registration, licensing, and inspection fees in the environment and rangeland protection fund rather than the general fund. This is estimated to reduce general fund revenues by \$785,000 for the 2011-13 biennium.

Continuing Appropriations

Turkey fund - Chapter 4.1-12 - Commodity checkoff for market development for turkeys and turkey products.

Honey promotion fund - Chapter 4.1-08 - Commodity checkoff for market development for honey.

Minor use pesticide fund - Sections 4-35-06.2 and 4-35-06.3 - For studies, investigations, and evaluations regarding registration and use of pesticides.

Major Related Legislation

House Bill No. 1321 - Transfers anhydrous ammonia inspection duties from the Insurance Commissioner to the Agriculture Commissioner, eliminates the anhydrous ammonia storage facility inspection fund, and deposits anhydrous ammonia inspection fees in the environment and rangeland protection fund rather than the general fund.

Senate Bill No. 2085 - Allows the Agriculture Commissioner to assess a civil penalty to a person distributing or selling noxious weeds and allows the Agriculture Commissioner to use up to \$50,000 of the Department of Agriculture appropriation from the environment and rangeland protection fund for invasive weed control for the 2011-13 biennium.
