DAKOTA LEGISLATURE.

Thirteenth Session--- Daily Report of the Proceedings of the Council and House of Representatives.

NINTH DAY.

GENERAL COMMENTS.

Judge Kuykendall's bill to increase the number of justices of the peace and constables and provide for the election of the same, was passed by the council this morn-ing. Before being passed it was amended so as to apply only to the counties of Bon Homme and Grand Forks and the counties west of the Missouri river.

The chaplain of the council was a few minutes late this morning, and no member of the council volunteering to discharge his duty, the business of the day was entered upon without the usual invocation for divine aid. Considering this omission the members deported themselves with remark-

able circumspection.

Mr. Gray's bill for the prevention of fraudulent banking is designed to protect the public against irresponsible persons engaging in the business of banking. The main feature of the bill is the provision ing it a misdemeanor, punishable by heavy fine and imprisonment, for officers of a banking institution to receive money in deposit of such banking institution shall have became insolvent.

THE COUNCIL.

Wednesday, Jan. 22.-The council met at 10 o'clock s. m. and was called to order by the president.

Roll called; members all present

The minutes of vesterday's proceedings were read and approved.

REPORTS OF COMMITTEES.

Mr. Roberts, from the judiciary committee, reported back council bills 10, 11, 12 and 13, and recommended their passage, which was accepted.

Mr. MacNider, from the committee on enrollment, reported that council bills 2 and 8 were correctly eprolled.

Mr. Rohr, from the committee on elections, to which had been referred council bill No. 4, in relation to penalty on taxes, reported the same back with amendments making the act apply only to the counties of Clay and Union, and with these amend-ments recommend its passage.

Upon a motion to adopt the amendments

proposed to the committee, a discussion followed.

Mr. Roberts said that the fundamental principle of taxation was that it should be uniform; and that wherever any inequality is shown it vitiates the entire levy. This law gives special priviliges to the counties of Clay and Union, and if passed, the gene-ral law applying to the balance of the territory could not be enforced.

Messrs. Cuppett and Edmunds took the same view, and were of the opinion the bill proposed legislation which would be coned as making taxation illegal.

Mr. Gamble moved that Mr. Gray be appointed to the vacancy on the commit of enrollment and engrossment, caused by the withdrawal of Mr. Stephens.

Mr. Gray, having understood that Mr. Gamble's reference to this matter was in the nature of a suggestion, and not of a motion, raised a point of order that a suggestion was not a motion.

The speaker overruled the point of order. Mr. Stephens moved as an amendmedt that the name of Mr. Walton be substituted

for the name of Mr. Gray.

Mr. Gamble insisted that, as Mr. Gray was a gentleman peculiarly adapted to the performance of the duties of chairman of the committee on enrollment and engrossment, the amendment should not prevail.

Mr. Gray considered the whole scheme for his appointment a conspiracy-besides his eyesight was not good. He had had much trouble with his eyes and was thereby unfitted for the task of reading lengthy bills and could not do justice to the

Further debate ensued, but the result of a vote was the rejection of Mr. Stephens amendment and an adoption making Mr Grav chairman of the committee.

Mr. Gray gave notice that he would take early occasion to move a reconsideration of the vote by which the motion was adopted.

Mr. Stephens called up the report of the custodian of the territorial library and asked that it be read.

It was accordingly real at length. On motion of Mr. Stephens, the report was referred to the judiciary committee. ADJOURNMENT.
