GENERAL COMMENTS

GENERAL COMMENTS Day's bill for the modification of the ex-emption law has not yet been reported by the judiciary committee to which it was referred on its second reading. It will probably be reported to-morrow and a vote taken on its passage. The bill to amend the charter of the city of Vermillion which passed the council this morning, reduces the election precincts from six to one. It is claimed that one

Mr. Langness' local option bill being the special order in the house for eleven o'clock this forenoon, a large number of ladies and gentlemen were assembled upon the floor and in the gallery of the houre by the time that hour arrived. Ladies were particularly numerous, their coming having been arranged yesterday afternoon at the instance of Mrs. Governor Howard, who takes a leading interest in all matters pertaining to temperance reform. They came as a sort of a moral force, to encourage by their presence the friends of the bill and sure them that the measure was one hich encountered their heartiest sympawhich encou pathies. The opponents of the bill, being weak in numbers, but strong in parliamen-tary resorts, anticipated the hour of the special order by instituting fillibustering movements which demoralized the form avrayed in favor of the measure before the time for action came. These tactics were followed up and the house crowded into committee of the whole in spite of the intention of the majority to permit no delay in bringing about immediate final action. In committee of the whole a couple of amendments were carried and balance of the time was consumed in dilatory motions. The house was, finally, after two hours' struggle, brought to an almost unanimous adjournment without a call for the previous question or anything pertaining to final action. There is now a dis position among its advocates to throw the hill aside and substitute a measure which shall be prohibitory in its nature. Mr. Langness bill, as it no stands, provides that on and after the general election in 1879 the question of granting licenses permitting the sale of liquor in any county shall be submitted to a vote of the electors of the county and as the majority decides so will the sale of liquor be permitted or not permitted. An effort was made in the committee of the whole to confine the operations of the proposed law to the counties of Minnehaba, Lincoln, Union and Clay, but it was voted down. An unsue cessful effort was also made to except the counties of Bon Homme and Richland from

the measure. The bill will be brought to a test in the house to morrow in its regular order, that of unfinished business.

In committee of the whole the time was largely consumed by dilatory motions and general fillibustering tactics of the minority which opposed the bill. By this course the committee was held in session nearly an hour. It finally rose and reported back the bill with amendments changing the date of the first election under the proposed bill from 1380 to 1879, and prohibiting the sale of liquor in unorganized counties, and recommended its passage.
