SEVENTEENTH DAY.

GENERAL COMMENTS.

In our yesterday's report we stated that Mr. Brown, of the house, asked to be, and was, excused from attendance until next Monday. This was an error on the part of the reporter. Mr. Brown asked to cused for non-attendance on Monday last and was so excused. In the confusion which existed at the time, the reporter misinter

preted Mr. Brown's request.

The bill upon which a call of the h was made this morning and a final adjournment effected without a vote being reached is Mr. Kuykendall's bill, permitting any rate of interest which may be contracted upon between parties. Mr. Kuykendall is member of the council from the Black Hills and when the bill came to a vote in the house it was discovered that the two house members from that district were absent. Without deeming this an intentional act upon their part, the house thought it advisable to procure their views upon the bill, as it was made more particularly for the benefit of their district, and the sergeant at arms was sent out to bring in Mr. Flick and Mr. Whitfield, He failed to find the former, whereupon the house adjourned without action upon the bill, in order to give the Black Hills members an opportunity to cast their votes upon the measure.

A bill was introduced to-day by Mr. Gunderson, of Clay county, providing for the relief of the bondsmen of R. J. Simonson, an ex-treasurer of Clay county, whose money and books were destroyed by fire The bill suthorizes the commissioners of Clay county to credit Mr. Simonson with something over \$3,000, the amount of his shortage. It was introduced by Mr. Gunderson upon the petition of sixty nine citizens of Clay county.

THE COUNCIL.

Mr. Miner was called to the chair, and took a seat at the clerk's table.

Mr. Valentine raised the point of order that the chairman was not in his proper place—that he should occupy the president's

Mr. Miner stated that whils acting as chairman of the committee he would run it as he thought was the correct way, and if the committee didn't like it, it could put ebody else in the chair.

Mr. Valentine called the chair to order and insisted that he should take the president's chair.

The chairman retorted that he knew his place and would retain it.

Mr. Valentsne-I appeal from the decision

Mr. Miner-The chair will not entertain any such proposition.

At this point the president resumed the chair and stated that as the committee was out of order he took the chair to place it in

Mr. Edmunds then moved that the conn cil go into a committee of the whole on the insane bill, which motion prevailed, and Mr Boberts took the chair.

The bill was considered by sections, and variously amended, but without concluding the consideration of the amendments proposed, on motion of Mr. Kuykendall the committee rose, reported progress and asked leave to sit again
