House

AFTERNOON SESSION. Thursday, Feb. 3 .- The order of busiess was gone through with, to clear up the clerk's table.

BILLS INTRODUCED. By Mr. Hale-House file'seventy-five, providing for the sale and purchase of live stock in the counties of Lawrence, Pennington, Custer, Mandan and Forsyth.

COUNCIL BILLS.

Council Bill thirty-five—Authorizing the issue of bonds for the construction of a hospital for the insane and to authorize the building of the same, had its first reading. Council bill thirty-one—To provide

funds for the construction of a penitentiary at Sioux Falls and for other purpos had its second reading and was reter es, red to the committee on penal and charitable institutions.

Council Bill thirty-nine-to make the town plat of Edwinton the legal plat of the city of Bismarck, had its second the city of Bismarck, had reading and was referred to the committee on counties and townships.

Council bill ,forty-one-Amending the act providing a school board for the vil-lage of Sioux Falls, had its second reading and was referred to the committee on education.

HOUSE BILLS.

House files sixty-three-Creating the county of Ole Bull, was read a second time and referred to the committee on counties and townships.

House file sixty-four-For furnishing and maintaining the territorial hospital for the insane, had its second reading and was referred to the committee on charitable and penal institutions. The bill appropriates \$16,000 for the maintenance of patients and their necessary clothing and for the board of employees and offi cers, \$8,000 for wages of employees, \$2.-500 for fuel and lights, \$500 for incidental expenses, \$1,000 for drugs, medicines books, \$1,500 for repairs and improve-ments and \$2,500 for necessary improvements on the hospital farm-a total of \$32,000.

House file sixty-six--To protect and encourage sheep husbandry and to provide a bounty for wolf scalps, had its sec ond readins and was referred to the committee on territorial affairs.

House file sixty-six-Relating to the re-location of the county seat of Grant county, had its second reading. The bill provides that a majority vote be considered sufficient to move the county seat of Grant county, while the general law provides that no county seat can be moved excepting by a two-thirds vote.

On motion of Mr.Dickey the rules were suspended. Mr. Landman moved that further consideration of the bill be indefinitely postponed.

YANKTON, DAKOTA TERRITORY, FRIDAY EVENING, FEBRUARY 4, 1881.

Mr. Donaldson, the author of the bill, protested against this summary action and asked that the bill be put through its regular course under the rules.

Mr. Landman's motion was adopted and and further consideration of the bill was indefinitely postponed.

COUNCIL BILL EIGHT.

Mr. Wells called the attention of the house to council bill eight, providing for the construction of a jail for Lincoln county, vetoed by the governor and his veto sustained by the house and moved a reconsideration of the vote by which such veto was sustained.

Mr Thompson vigorously opposed this action and held that it was entirely out of order.

Mr. Van Osdel moved that the motion to reconsider be laid upon the table, and his motion was lost.

CALL OF THE HOUSE.

On motion of Mr. Hale, a call of the house was ordered and the roll call showed that Mr. Cross was absent. On motion of Mr. La Moure, further

proceedings under the call of the house were dispensed with, and, on motion of Mr. LaMoure, Mr. Cross was excused. He was busy on committee work.

COUNCIL BILL EIGHT. Mr. Wells' resolution for a reconsidera-

tion of the vote by which the veto was sustained was put and lost-twelve to twelve.

HOUSE FILE NINETEEN

The committee on enrollment reported house file nineteen, providing for the erection of a court house and jail in Richland county, as correctly enrolled, and the speaker called the attention of the house to the singing of the bill.

ADJOURNMENT. On motion of Mr.Ellefson, the house, at 3:35 p. m., adjourned until ten o'clock to-morrow morning.

Council.

Friday, February 4.-The council met at 10 a.m., and was called to order by the president.

Prayer by the chaplain.

Roll call showed all members present. Minutes read and approved. MESSAGE FROM THE HOUSE.

A message from the house announced the passage of council bill seventeen, to amend the act authorizing the bonding of the indebtedness of Bon Homme county, with amendments.

Council bill five, to amend section one chapter nineteen, of the political code. Council bill twenty-three, to amend

ection 1,748 of the civil code: And house file 46, 49 and 54, and requesting the concurrence of the council

therein. REPORTS OF STANDING COMMITTEES. Mr. Shaw, from finance and expenditures, reported with amendments council bill 33, to amend section 48 of the political code, and chapter 49 of the laws of 1879, and recommended its passage.

Mr. Day, from the committee on counties, reported and recommended the pas-sage of house file 30, to incorporate the village of Parker.

Mr. Gamble, from the judiciary mittee, reported back council bills 44, 45, 46, 49, 58 and 63, recommending their

Mr. Wiggin, from the committee on agriculture, reported back house files 39 and 42, and recommended their pass Mr. Wallace, from the committee on immigration reported back and recom-

mended the passage of house file 38. Mr. Scobey, from the committee on education, reported back house file 31, being the bill providing that the German and Scandinavian languages be taught one hour each day in the public schools of the territory, and recommended that the same do not pass

Mr. Gamble moved that the report of the committee be laid on the table.

Upon this motion a discussion ensued, in which Messrs. Wilson, Gamble and Day supported the motion and the objects of the bill, and Messrs. Scobey, Wallace, Wiggin and Fisher opposed the motion and argued against the principles involved in the measure.

After the discussion had lasted for some time, Mr. Jolley stated that there were three members of the council who couldn't make speeches, and they were unable to comprehend what the debate was about. A motion to lay the report of a committee upon the table was an unusual proceeding and was discourteous to the committee. When the bill comes up in order for its third reading then is the time to give an opinion upon the report of the committee by voting the bill down, or up.

Mr. Gamble withdrew his motion.

Mr. Rohr, from the committee on territorial affairs, reported house file sixty-six with a recommendation that it pass. It provides for the protection of sheep husbandry and for bounties for wolf scalps.

Mr. Kennedy, from the committee on engrossment, reported corrections tohouse file 38, authorizing the commissioners of Hutchinson county to fund the indebtedness of the county, and reported bill correctly engrossed. House file forty-seven, legalizing certain acts of the commissioners of Lawrence county, was also reported correctly engrossed.

Mr. Kennedy, from the committee on enrollment, reported house file eleven correctly enrolled. It legalizes acts of officers of Dell Rapids village.

COUNCIL BILLS.

The following council bills had their first reading:

Number thirty-two-amending section eleven of chapter thirty-nine of the political code, fixing fees of coroners.

Number fifty-one-giving permission to residents of the counties of Lawrence, Pennington, Custer, Mandan and Forsyth to contract for any rate of interest. Number fifty-two—To repeal section 427 of the penal code so far as it relates to the Black Hills counties.

Council bill thirty-five-Authorizing the issue of bonds for the construction of an insane hospital, was read a second time and referred to the committee on penal and charitable institutions.

Council bill forty-Amending the pub-lic school law, had its second reading and was referred to the committee on education.

Council bill twenty-one — Au-thorizing county commissioners to levy a tax of not more then six mills on the dollar, had its third reading and was passed; Messrs. Dick-ey and Hale voting in the negative and all the rest in the affirmative.

HOUSE BILLS. The following house bills had their second reading and were referred as indicated .

Number sixty-nine-For the protection of game and fish, to the committee on territorial affairs.

Number seventy-Providing for the equalization of taxes in certain townhips, to the committee on counties and

townships. Number seventy-one — creating the county of Vermillion, to the committee on counties and townships.

Number seventy-four-to amend section 1,101 of the civil code, to the committee on judiciary. House file forty-seven-legalizing cer-

tain acts of the commissioners of Law-rence county, had its third reading and was passed by a unanimous vote.

inal cases. That house file sixty-six pass. It provides for the protection of sheep hus bandry and authorizes the payment of bounties for wolf scalps. That the substitute for house file thirty-five pass. It creates the county of Walsh. On motion the report of the committee

of the whole was accepted and adopted. ADJOURNMENT.
