## DAKOTA'S LEGISLATURE.

The Press and Dakotaian's Report of the Proceedings of the Council and House of Repre-

sentatives.

## Fourteenth Session-28th Day.

#### Council.

Monday, February 7.-The council met at 10 a. m., and was called to order by the president.

Prayer by the chaplain. Roll call-members all present except Mr. Walsh, of Union.

Minutes read and approved. Mr. Scobey was called to the chair.

MESSAGE FROM THE HOUSE.

A message from the house announced the passage by that body of council bills 22 and 24, and the rejection of council bill 38, to amend section 7, chapter 39 of the political code; also the passage of house file 35, 66 and 82.

COMMITTEE REPORTS

Mr. Jolley, from the committee on enrolled and engrossed bills, reported that council bill 6, relating to an increase of compensation to the judge of the first district, passed over the governor's veto, had been placed on file in the offie of the secretary of the territory.

Mr. Day, from the committee on counties, reported with amendments council bill 35, amending the act creating a board of education for the city of Yankton. and recommending its passage.

Mr. Gamble, from the judiciary com mittee, reported the following bills:

House files 34, 46, 52 and 57, recom mending their passage, with certain amendments. Council bill 60, to amend section 2 of

chapter 26 of the session laws of 1879; and. Council bill 59, in relation to attorney

fees in justices' court.

Mr. Jolley, from the committee on enrolled and engrossed bills, reported certain bills correctly enrolled.

Mr. Day, from the special committee, composed of the members from Bon Homme, Clay, Union and Lincoln countics, reported house file 49, relating to short hand reporters in those counties, recommending its passage.

Mr. Gamble presented a majority re-port in favor of the passage of council bill 47, relating to fees of district attorney in the first district.

Mr. Wilson moved that the report be adopted, which motion was lost. The bill was then recommitted to the

judiciary committee. Mr. Wilson, from the committee on elections, reported with amendments council bill 26, providing for the canvass of votes cast for county officers.

CONCURRED IN. On motion of Mr. Jolley, the council concurred in house amendments to councill 22.

county commissioners; to the judiciary committee. No. 68, to amend section 7, chapter 39 of the political code: laid on the table for

third reading. The following council bills were read a third time and passed.

No. 55' to amend the act establishing a board of education for the city of Yank-

ten. No. 59, in relation to attorneys' fees

in justices' courts. No. 60.to amend sec. 2.chapter 36.of the laws of 1879. Ayes 10, noes 1-Mr. Day voting in the negative. [The bill make

saloon licenses expire on the first of April. No. 62, to amend section 332 of the

code of civil procedure-Messrs. Day and Wiggin voting in the negative.

No. 26, providing for the canvass of votes for county officers.

HOUSE FILES. No. 38, read a second time and referred to committee on finance and expenditures.

No. 47, read a second time and referred

to judiciary committee. House tiles 27, 32, 46 and 49 were read a third time and passed.

POSTFONED. Council, bill 36, to amend section 1804

of the civil code, made a special order for to-day, was postponed until tomorrow.

INTRODUCTION OF A BILL. Mr. Wilson, by unanimous content, in-

troduced a bill for an act providing for the purchase of one thousand copies of a compiled edition of the revised codes of Dakota ferritory, which was read a first time.

MESSAGE FROM THE HOUSE. A message from the house announced the passage of house file 59, to incorporate the city of Deadwood, and 63, to create the county of Griggs, and requested the concurrence of the council therein.

### ADJOURNMENT. On motion of Mr. Jolley the council djourned.

House. Monday, Feb. 7.-The house convened at ten a. m. and was opened with prayer by the chaplain. Mr. Speaker in the chair and all the

members present, excepting Van Osdel. The journal of the preceding session was read and approved.

COUNCIL MESSAGE.

A message was received from the conn cil, announcing the passage by that body of council bills eighteen, substitute, and fifty-seven. Also house file five. Also that the council had re-ceded from its amendments to the joint resolution providing for printing the reports of territorial officers Also that the council had concurred in

house amendments to council bill twenty-one. The bill amended provides for a levy of not more than six mills tax by county commissioners. COMMITTEE REPORTS.

Mr. Kennedy, from the committee on engrossment, reported as correctly engrossed house file sixty-three, creating the county of Griggs, and house file fourteen, providing for a registry of voters. The committee asked leave to make correction in house file forty-one, authorizing the commissioners of Barnes county to is sue bonds.

Mr. Inman, from the committee on in surance, banks and banking, reported back conncil bill fifty-one and house files fifty-five and seventy-seven with a rec ommendation that they pass. Council bill fifty-one exempts the Bluck Hills counties from the provisions of the in-terest law. House file seventy-seven repeals the act relating to corporations and persons engaged in the banking hnginoge

Mr. Cross, from the committee on char itable and penal institutions, reported back house file sixty-four with amend ments and a recommendation that it pass. The bill provides for furnishing and maintaining a hospital for the insane

Also house file fifty-two, providing for a building committee and the better management of the hospital for the insane, with amendments, and a recommendation that it pass.

Mr. Warner, from the committee on edacation, reported back house file thirtyseven with amendments and recommended its passage. The bill provides for a territorial board of health and regulates the practice of medicine.

Mr. Boyles, from the committee on judiciary, reported back council bill thirteen with amendments and recommended its passage. It provides rules for the execution of trusts under the act of congress for the relief of inhabitants of cities and towns upon the public lands.

Also house file six, with a recommendation that it be indefinitely postponed, It is of the same nature as council bill thirteen

Mr. Kennedy from the committee on engrossment reported house file forty. one as correctly engrossed. It authorizes Barnes county to issue bonds.

RECONSIDERED.

Dakotaran.

Mr. Thorne moved that the vote by which the house concurred in the coun cil amendment to house file thirty-one, relating to instruction in foreign lan guages in the public schools, be recon-sidered and it was so ordered, after a discussion, which developed a desire up on the part of the Scandinavian members to have their language included in the provisions of the law.

On motion of Mr. LaMoure the house refused to concur in the council amendment. NOTICES OF BILLS.

HOUSE BILLS.

The following house bills had their second reading and were referred as indicated:

Number sixty-one, to incorporate the village of Egan, Moody county, to the committee on corporations.

Number eighty, to define the boundaries of the county seat of Richland county, to the committee on counties and townships

House file fourteen, for the registry of voters and to prevent fraudulent vot-ing, came up for its third reading, but was finally committed to a special com-mittee, consisting of Messra. Wells, Boyles, French, and VanOsdel, with instructions to provide a substitute for the amendments offered.

House file sixty-three, to create the county of Griggs and define its boundaries, was passed by unanimous vote. House file fifty-nine, incorporating the city of Deadwood, was passed by unani-

mous vote. COMMITTEE OF THE WHOLE.

On motion of Mr. Wells, the house, at 10:40 a. m. went into committee of the whole, on the general order, Mr. Wells in the chair.

THE COMMITTEE ROSE

at 11:45 a. m. and made the following report to the house which was received and adopted:

That council bill thirteen, for the exetion of trusts arising from the passage of a congressional act for the relief of the inhabitants of cities and towns on public lands be passed as amended. That council bill thirty-one, providing

a fund for the construction of a peniten-

tiary at Sioux Falls, pass as amended. That council bill thirty-four, amending the act incorporating the city of Elk Point, pass.

That council bill forty, amending the public school law, pass as amended.

That house file fifty-two, providing for the building of a hospital for the insane and the government thereof, pass as amended.

That house file thirty-seven, providing for a board of health in the territory of Dakota and regulating the practice of medicine in the territory do not pass.

That council bill forty-one, amending the act providing a board of education for the village of Sioux Falls, pass.

That council bill fifty-one, exempting the Black Hills counties from the provisions of the interest law, pass. That house file six be indefinitely post

poned. That house file fifty-five, providing for

the issue of bonds for the completion of a jail in Minnehaha county, pass.

That house file sixty-four, for furnishing and maintaining the hospital for the insane, pass.

That house file seventy-seven, for the repeal of the act concerning corporations and persons engaged in the banking bus iness, pass.

BILL SIGNED. Council bill seventeen, having been reported correctly enrolled, was signed by the speaker. It provides for funding the indebtedness of Bon Homme county. A BILL PASSED.

On motion of Mr. Thorne, council bill thirty-one, providing for the construction of a penitentiary at Sioux Falls, reported favorably from the committee of the whole, was put upon its final passage, and passed by unanimous vote. ADJOURNMENT.

On motion of Mr. McBratney, the house, at 11:50 a. m., adjourned until ten o'clock Tuesday morning.
