

DAKOTA'S LEGISLATURE.

The Press and Dakotaian's Report of the Proceedings of the Council and House of Representatives.

Fourteenth Session .- 44th and 45th Days

Council.

AFTERNOON SESSION. The council reconvened at 2 p. m with the president in the chair and all members in their scats. HOUSE FILES

No. 149, providing for the appointment of a board of commissioners to rep resent Dakota at the international exhibition of 1883. The bill authorizes the expenditure of twenty-five thousand dollars for the puspose of displaying the products and advantages of Dakota at that exhibition.

After a discussion in regard to the pro-visions of the bill and a general expression that it required amendment, it was, on motion of Mr. Martin, re-committed to the judiciary committee.

CORRECTLY ENROLLED.

Mr. Jolley, from the committee on en grossed and enrolled bills, reported the following council bills correctly enrolled:

the city of Fargo. Mr. Shaw, from the committee on finance and expenditures, reported and recommended the passage of house 177, making an appropriation to compensate the chief clerks for closing up their journals.

Also, house file 70, providing for the equalization of taxes in certain cases. with a recommendation that it do not Mr. Wiggin, from the committee on

agriculture, reported without recom-mendation, house file 151, relating to fire guards.

Mr. Walsh, from the committee on highways and bridges, reported, with amendments, house file 148, for a bridge over Hart river.

Mr. Gamble, from the committee on judiciary, reported without recommendation, house file 127, to amend chapter 60 of the penal code.

Also, recommending the passage of Also, recommending the passage of council bill 145, to amend section 67, of the code of civil procedure and a majority report recom-mended the passage with amendments of house file 149, providing a board of commissioners for the international exhibition of 1873.

Mr. Jolley, from the judiciary committee, presented a majority report re-commending that house file 149 do not pass.

Mr. Day, from the committee on counties, reported back house file 118 and recommended its passage.

Mr. Wilson, from the judiciary committee, reported a substitute for council bill 151, relating to mechanics' liens, recommending its passage.

INTRODUCTION OF BILLS

Unanimous consent being given, Mr. President introduced a bill relating to the redistricting of the county of Grand Forks, which under a suspension of the rules was read three times and passed.

Mr. Wiggin introduced a bill to vacate a certain portion of the town of Canton, which was read the second time and referred to the committee on counties.

MESSAGE FROM THE HOUSE.

A message was received from the house announcing that the house had appointed conference committees on the disagreement of the two houses on house files 14, and 173, and also that the house had passed house files 220, 221, 222 and 223.

Mr Day moved that the council do not recede from its amendments to house file 14. The bill provides for a registry law, and the council amendments exempted Brule county from its provisions. The motion was lost.

On motion of Mr. Scobey the council receded from its amendments.

The president appointed Messrs. Fisher, Gamble and Scobey a conference committee on house file 173.

RECONSIDERED. On motion of Mr. Scobey the joint resolution recalling from the governor council bill 101, was reconsidered. COUNCIL BILLS.

MESSAGE FROM THE HOUSE. A message was received from the house announcing the passage of council bill1 60, relating to re-districting Grand Forks county and house file 225, to amend section 2 chapter 21, of the political code.

On motion of Mr. Jolley, the rules were suspended and house file 225 passed. It makes the elections on odd numbered years "annual elections," and those on even numbered years, "general elections.

the deaf and dumb of Dakota territory. No. 119, to define the boundaries of the judicial district of the territory of Dakota and to sub-divide the same and to fix the terms of court therein and for other purposes.

No. 72, authorizing the several school districts of Grand Forks to issue bonds. No. 92, locate and establish a state agricultural college. HOUSE FILES

House. AFTERNOON SESSION.

Wednesday, Feb. 23-The house re-con-vened at 2:30 o'clock p. m., Mr. Speaker in the chair and all the members present. BILLS INTRODUCED.

Mr. La Moure, by unanimous consent, introduced house file 220, giving copies

of the revised codes and session laws to the members of the legislature and cer-tain territorial officers. Under a suspension of the rules, the bill had its several readings and was passed.

Mr. La Moure, by unanimous consent, introduced house file 221, to amend the title to the bill providing a new city charter of Fargo. Under a suspension of the rules, the bill had its soveral readings and was passed.

Mr. Thielman, by unanimous consent. introduced house file 222, toamend the act incorporating the village of Parker. Un-der a suspension of the rules, the bill had its several readings and was passed. Mr. Thielman, by unanimous consent, introduced house file 223, to vacate the townsite of Freedom, in Turner county. Under a suspension of the rules, the bill had its several readings and was passed. COUNCIL MESSAGE.

A message was received from the council announcing the passage of council bills 141, 154, and 158, and house bills 73, 91, 139 and 178, with amendments. Al-so that the council had passed council bill 83 over the veto of the governor.

ACTION ON VITOED BILLS.

Council bill 71, to re-district the county of Grand Forks into five commission er districts, vetoed by the governor, came up as the special order, and Mr. La Moure moved that the bill pass, the objections of the governor to the contrary, notwithstanding. A vote was taken and it finally stood seventeen to six, and the bill was passed over the veto. Messrs. Cross, Ellefson, French, Landmann, Thompson and Mr. Speaker voted in the Mr. Van Osdel was excused, regative. and all the rest voted in the allirmative. Council bill eighty-three, establishing an independent school district, embrac-ing the town of Grand Forks, in the county of Grand Forks, vetoed by the governor, was called up as a special or der and the question being, shall the bill pass, the objections of the governor to the contrary, notwithstanding, the vote was taken and it stood unanimous for the passage of the bill and it was passed over the veto.

RE-CONSIDERATION.

Mr. Dickey moved a re-consideration of the vote by which council bill 100 (ordering the issuing of county warrants when the accounts are due, whether there is money in the treasury or not) was adopted, and the bill was referred to the committee on counties and townships.

Mr. Warner, from the committee on education, reported back house file 140 with a recommendation that it pass, house file 195, that it pass, council bill 132 that it go to the committee of the whole, house file 139 that it pass, house file 130 that it pass.

Mr. Wells, from the committee on railroads, reported back house file 195 with a recommendation that it pass

Mr. Boyles, from the committee on ju diciary, reported back house file 102, with a recommendation that it pass. RECONSIDERATION

Mr. Kennedy, from the committee or counties and townships, reported back house file 197 without recommendation and house files 200 and 25 with a recommendation that they pass.

Mr. Ellefson, from the committee on agriculture, reported back house file 112 with substitute and a recommendation that it pass.

Mr. Inman, from the committee on insurance, banks and banking, reported back house file 104, amended and with a recommendation that it pass.

Mr. Cross, from the committee on charitable and penal institutions, report-ed back house file 104 with amendments and a recommendation that it pass. Also, from the committee on immigration, council bill ninety-one without recommendation. The latter provides for a territorial board of immigration.

A motion for the reconsideration of the vote by which 108 and 128 were lost was laid upon the table.

Number 92, providing for boards of education for the cities of Deadwood and Bismarck, was passed by unanimous vate

Number 101, a memorial to congre asking for an increased appropriation for the surveys of public lands, was passed by unanimous vote.

Number 206, to enable the counties of Grand Forks, Walsh and Pembina to is sue bonds for the construction of rail-roads, was passed by ananimous vote. Number 195, providing a board of ed-ucation for the city of Dealwood, was passed by unanimous vote.

Number 130, to provide for a general and uniform system of schools, was passed, 18 to 3, Mesars. Donaldson, Thompson and Van Osdel voting in the negative.

Number 102, to repeal section three, chapter 20, of the session laws of 1879, relating to fees of county treasurers, was passed.

Number 142, to amend subdivision 14, section two, chapter 28 of the political code, entitled revenue, was passed by unanimous vote. Number 189, to locate, establish and

endow a state normal school, was passed, 15 to 5, Measra, Cross, Ellefson, Rohr, Thompson and Van Osdel voting in the negative, Number 143, regulating the duties of

county assessors and for other purposes, was passed, 15 to 5, Messrs. French, Inman, Rohr, Thielman and Thompson voting in the negative.

Number 146, to amend chapter 30 of the political code, was rejected, 16 to 4, Messrs, Baynes, Dickey, Landman and Warner voting in the negative.

Number 173, authorizing the publica-tion of 5,000 copies of the public school law and appropriating money for the payment of the same, was passed, 17 to 3, Mesars, Dickey, Inman and Landmann voting in the negative. Number 186, was passed by unanimous

vote.

Number 187, to provide for drawing school funds four times a year, was pass ed by unanimous vote.

Number 193, to amend chapter 39 of the political code, relating to millers' rights, was passed by unanimous vote. Number 191, to amend sections three

twenty-nine and thirty-six, of chapter twenty seven of the political code, was passed by unanimous vote.

Number 198, to increase the pay of the assessors in the counties of Pennington and Caster, was passed by unanimous

Number 216, to amend the act incorpo rating the village of Jamestown, was passed by unanimous vote. Number 225, introduced by Mr. Wella,

by unanimous consent, was passed under a suspension of the rules. It amends section two, chapter 21 of the polititical

Mr. Wells moved that Mr. PaMoure be excused from further attendance upon the legislative session, and the motion was adopted by unanimous vote, after a few complimentary remarks by Mr. Boyles and Mr. Speaker.

On motion of Mr. Rohr, the rules were suspended and house file 180 was taken up, placed upon its third reading and final passage and was passed by unanimous vote. It provides for the collection of taxes on personal property.

Mr. Boyles, from the judiciary co mmittee, reported back house file 125 with amendments and a recommendation thatit pass, and house bill 145, without recommendation.

Mr. Van Osdel moved that the rules be suspended and that house file 112, to repeal the herd law during the winter months, be placed upon its third reading and final passage, and the motion was adopted. The hill being put upon its final passage, the vote stood, 16 yeas, 4 nays, and it was passed, Mesars. Inman, Kohr, Thompson and Warner voting in the negative

Mr. Doualdson from the committee on ways and means, reported back house file 20, with a recommendation that it pass. ADJOURNMENT.
