DAKOTA'S LEGISLATURE.

A Complete Report of the Proceedings of the Council and the House

Fiftcenth Session-Fourth Day, Council.

FRIDAY FORRNOON. Called to order by President Scobey at ten o'clock.

Prayer by the chaplain.

Reading of the journal. Mr. Dewey thought rules 20 and 21 in maistent.

After talking on the subject was decided that on the first reading of a bill the question, "shall the bill be re-jected", is before the house without any motion to that effect.

REPORT OF COMMITTEES. Mr. Walsh, of the joint committee on rules for both houses when in joint ses-

sion, made a report. The rules as reported by the committee

ere read by the clerk.

Mr. Nickeus moved to amend rule eight by extending its provisions for the safe keeping of joint resolutions to concurrent resolutions. Carried. Mr. Dewey offered an amendment in

the shape of a new rule, which provides that in joint sessions the officers of the council shall be the officers of the body and the officers of the house assistants. At this point a message was received

from the house announcing the adoption by that body of the report of the joint committee on rules. Mr. Walsh thought it would now be

impossible to amend the rules further in the council as they had been adopted in the house. Mr. Nickeus thought the committee

action was not final and that the rules should go to the house as amended and the amendments be adopted by them. Mr. Dewey's amendment was then

Mr. Walsh moved the adoption of the

rules as amended. Carried. NOTICE OF BILLS.

Mr. Jackson gave notice of a bill to amend section 15, 16, 17, 18 and 19 of chapter 118 of the laws of 1881. Mr. Roberts gave notice of a hill to

create and define the boundaries of the county of Steel.

Mr. Nickeus gave notice of a bill to provide a charter for Jamestown, Stutsman county. INTRODUCTION OF BILLS

Mr. Jerauld introduced council bill No.

7, to repeal chapter 107 of the laws of the 4th legislative assembly. The message from the house was then

taken up. Mr. Roberts moved that the report be returned to the house with the amend-

ments made in the council. Carried. READING OF BILLS.

Council bill No. 7 was read.

The president asked in what manner bills should be referred to committees. It was decided that the president should refer them to the committees without motion.

SECOND READING OF BILLS.

Council bill No. 2 was given its second reading.

Mr. Ziebach moved that rule 22 be so mended that on second reading of bills they be referred to committee unless objections are raised. Carried.

Council bill No. 3 was given its second eading.

Mr. Jerauld moved a suspension of the rules and that the bill be put on its third reading and passed. Carried.

The bill was read the third time and on the question, "shall the bill pass," all the members voted aye. This changes the name of Peder H. Halvorsen to Peter H. Hall.

Council bill No. 8 was now read.

Mr. Jerauld moved a suspension of the rules and that the bill be put on its

the reacting and that the bill be put on its third reading and passed. This bill is to change the name of Paul O. Thompson to Paul O. Tomt. Mr. Ziebach objected to such legisla-tion, helding that the coarts are the proper place to apply for such relief.

Mr. Jerauld spoke in support of his motion. The motion was put and division called for. Motion lost.

Council bill No. 5 was read.

Mr. Nickens moved that the bill be read a third time under a suspension of the rules. Carried.

The bill was given its third reading and Mr. Jerauld moved an amendment which Mr. Nickeus explained was unnecessary. Amendment withdrawn. Mr. Dewey supported the bill and

thought some such law should be made general.

On the question of its passage all voted aye. This extends the time when taxes of

1882 become delinquent to the fourth Monday in May. Council bill No. 6, to protect the fish

in Spirit lake was given its second read-ing and referred to the committee on railroads.

Mr. Dewey offered a resolution that the judiciary committee examine and report their construction of the herd law. Mr. Roberts and Washabaugh, mem

bers of the committee, objected, claiming that it was not the duty of the com mittee to deliver legal opini

Mr. Washabaugh moved that it be re ferred to a select committee. Amendment accepted. Mr. Nickeus asked for a re-reading of

the resolution. Granted. The ayes and nays being called the

Also a message announcing that the house had ordered two hundred copies of the rules of the council and house and 2,500 copies of the governor's mes sage printed.

Mr, Walsh moved that the message from the house in regard to the trip Sioux Falls be taken up and adopted. The president stated that he had a communication from the governor on the ame subject.

Mr Walsh withdrew his motion.

Mr. Jackson, as the member from the district in which Sioux Falls is situated expressed a wish that the committee would make arrangements for an extend ed stay in that city, and assured them hearty welcome.

The committee on charitable and pens institutions was made a committee to confer with the committee appointed by the house to make arrangements for the

Mr. Burdick moved that they leave Yankton on Monday morning and return by Tuesday noon.

Mr. Ziebach moved to amend the me tion so as to let the committee fix the time. Amendment accepted. Carried.

The council then took an informal recess, from which it was called to order on receipt of a message from the house announcing the passage by that body of council bill No. 2.

Mr. Dewey, chairman of the committee to confer with the house committee in regard to the proposed trip reported in favor of leaving Yankton on Wednesday at 9:30, and returning Tuesday morning. Mr. Walsh moved the adoption of the report. Adopted.

Mr. Nickeus moved to adjourn to 10 o'clock to-morrow. Carried.

The house convened at ten o'clock, a. n., was called to order by the speaker. Praver by the chaplain.

Roll call showed all members in their seats.

The journal of the previous session was read and approved.

COUNCIL MESSAGE.

A message was received from the council announcing that the council had ordered printed one hundred copies of the rules and five hundred copies of the governor's message for the use of council. JOINT RULES.

Mr. Pyatt, from the committee on joint rules, reported that the council committee on the same work had been conferred with and the joint committee had agreed to report the joint rules of the last sion as the joint rules of the present session, with an amendment to rule ten, permitting the re-introduction of a de-feated measure upon the permission of two-thirds of either house or five days notice. The report was accepted and adopted.

RESOLUTIONS AND MOTIONS.

Mr. Sterling introduced a resolution rdering two hundred copies of the

rales for the use of the house, fifty of them to be deposited in the secretary's office for the use of the next legislature. The resolution was adopted.

Mr. Benson introduced a resolution ordering 2,500 copies of the governor's message for the use of the house.

Mr. Thompson moved to amend by making the number five instead of 2,-500. The amendment was defeated 4 to 20-Messrs. McAllister, Thompson, Tychsen and Van Wert voting in the af-firmative and all the rest in the negative The resolution was then adopted.

Mr. Pyatt moved that a standing com mittee of five on joint rules be appoint-ed. The motion prevailed and Messra. Pyatt, Rice, Sterling, Nowlin and Iuman were appointed.

Mr. Sterling moved that the chief clerk be instructed to inform the council of the adoption by the house of the joint rules adopted by the committee. Adopted.

COMMITTEE OF THE WHOLE. On motion of Mr. Inman, the house went into committee of the whole on the consideration of the governor's message, Mr. Thompson in the chair.

After a brief period THE COMMITTEE ROSE

but neglected to make any report.

Mr. Bowman moved that the message be read by its headings and its various sections referred to appropriate com mittees. This motion was adopted but subsequently reconsidered, and, on mo tion of Mr. Sterling, the subject was postponed until to-morrow morning. A RECESS

then occurred, subject to the call of the speaker. Recess was brought to and end by a council message announcing an amendment to the joint rules, which concurred in and the house adjourned to two o'clock, p. m.

AFTERNOON SESSION.

The house reconvened at two o'clock The speaker presented a communica tion from the governor, which stated that the Chicago, Milwaukee and St. Paul railroad company had placed a special train at the disposal of the legislature for a trip to Sioux Falls to in-

spect the penitentiary. Mr. Wynn moved that a committee of three be appointed to confer with a com-

cil committee relative to the proposed trip. Adopted, and Mesars. Wynn, In-man and Towner appointed. COUNCIL MESSAGE.

age from the council informed

the house that the council had appointed a committee to confer with the house committee relative to the proposed visit to the penitentiary; also that the council had passed council bill number two an act to employ an assistant sergeant-atarms in each house and to provide for their compensation.

On motion of Mr. Inman, the rules were suspended and the bill had its several readings and the bill passed, Messrs. McAllister, Thompson and Mr. Tychsen voting in the negative, Mesars. Bowman and Rice not voting, and the balance vot ing in the affirmative.

On motion of Mr. Robinson a committee of three was appointed to wait upon the secretary of the territory and request him to provide the house with a hall possessing better ventilation. Messers. Robinson, Nelson and Nowlin are the committee.

The committee to consult relative to the visit to the penitentiary, reported that they had agreed to go next Monday, and the report was adopted.

The house, at 3:45 p. m. adjourned to ten o'clock Saturday morning.
