A Complete Report of the Proceedings of the Council and the House.

Fifteenth Session -- Forty-Third Day.

Council convened at 10 a. m., Mr. President in the chair.

Prayer by the chaplain.

Roll call showed all members in their cats.

Journal read and approved.

MESSAGE PROM THE HOUSE.

INTRODUCTION OF BILLS.

The committee on education reported the message of the governor and accompanying draft of a bill for a school law with a recommendation that the message and the proposed enactment be referred to the committee of the whole. The report was adopted.

Session Notes.

Mr. Jerauld's council bill 145, introduced this morning provides for the appointment by the governor of three tax examine into all sources of revenue and secertain and report whether or not all classes of property are equally assessed and taxed under the present law; also whether capital stock of corporatio this territory whose stock is owned outside the territory is paying its share of the public burden, and also to report what new sources of revenue may justly be secured. The commissioners are to receive \$6.00 per day for the time actually occupied.

Mr. Burdick this morning introduced a resolution into the council calling the Bismarck penitentiary bill from the committee, and a lively and rather personal discussion ensued, in which members were accused of not telling the truth and of attempting to force one bill to the prejudice of another. After a spicy de-bate and many attempted amendments of the original motion the bill was made a special order for Thursday at 2 p. m., the hour previously fixed for the consideration of the bills for a peniten-

tiary at Fargo.
There was not much of interest in the house to-day, the order of business being quickly disposed of and an adjournment being reached a little after eleven o'clock. Mr. Thompson's bill to provide local taxation on railroad property was indefinitely postponed without debate, by a large majority
