#### MESSAGE FROM THE GOVERNOR

Bismarck, North Dakota, March 5, 1937.

Members of the House of Representatives, Twenty-Fifth Legislative Assembly of the State of North Dakota.

#### Gentlemen:

As Governor of the State of North Dakota, under Section 75 of the Constitution of the State of North Dakota, I do hereby state that in my opinion an extraordinary occasion has arisen, and I do hereby convene the Legislative Assembly into a Special Session, the same to convene at nine o'clock A. M., March 8th, 1937.

Pursuant to the Governor's call for an Extraordinary Session to convene at nine o'clock A. M., March 8th, the members of the House of Representatives assembled in the House Chamber and were called to order by Minnie D. Craig, Chief Clerk of the House of Representatives of the Twenty-Fifth Legislative Assembly of the State of North Dakota.

The list of members as certified for the Twenty-Fifth Legislative Assembly was again read, and roll call was had.

All members were present except Representatives Bjornson, Brusseau, Frosaker, Graham, Johnson, Just, Nelson of Cass, Obach, Oglesby, Sticka, Symington, Thompson, Wendland and Wolf.

So a quorum was declared present.

President Thoresen: "In accordance with the constitutional requirements we are about to receive the message of the Chief Executive of the state of North Dakota addressed to this Extraordinary Session of the Twenty-Fifth Legislative Assembly, and I have the honor and the privilege to present to you our Governor, William Langer."

#### Governor Langer:

A summary of the legislation that has been enacted at the recent session of the Twenty-Fifth Legislative Assembly shows that there has not been sufficient revenue provided for by the legislation enacted to finance the operation of our educational and other institutions, and carrying on the affairs of the State Government. This creates an emergency.

I have called this extraordinary session of the Legislative Assembly, in order that a sufficient revenue bill may be passed.

This Session should be short.

#### I recommend:

FIRST: That you enact an adequate income tax law with an emergency clause.

SECOND: That you appropriate money for the State Normal Schools at Valley City and Mayville, North Dakota.

THIRD: The Attorney General having held that the bill previously passed providing for the appropriation of Fifty Thousand Dollars with which to pay the farmers for cattle infected with tuberculosis was faulty, I vetoed the same. I recommend that the bill be changed to comply with the Attorney General's suggestion, and that the same be passed.

FOURTH: That the drivers' license law be re-enacted, with such rates as you think necessary.

FIFTH: Over six hundred measures have been submitted to you during the Regular Session. If perchance any measure was during the rush of work inadvertently neglected, or which you believe of sufficient importance to warrant its consideration now, I recommend that you give it your attention.

#### EXPLANATION OF VOTES

Mr. Frazier: It is high time we realized that the operation of a motor car on the public highways is a privilege—not a right.

Every automobile is potentially a lethal weapon. Properly used, it is one of man's most desirable mechanical servants. Improperly used, it is a terrible menace to the lives, health and property of everyone in the area it travels.

Rigid training is necessary to obtain a license to pilot an airplane—yet the plane travels empty airways where, generally speaking, it cannot endanger others. Locomotive engineers must likewise undergo years of arduous experience, and must prove their physical and mental competence and responsibility before being entrusted with a train—yet a train operates on tracks, and has no traffic congestion problems. Still, in most states, we allow anyone whether he be competent or incompetent, careless or reckless, good habits or bad—to drive a car on crowded arteries of travel, where the slightest error of judgment may cause death!

It is an undeniable fact that a considerable percentage of the people now driving should either be denied that privilege or forced to undergo a period of training to make them abler, safer car operators. Some of these people are physically incapable of driving properly. Many more are mentally incapable, congenitally incompetent, or reckless. And the toll is 35,000 lives a year.

We will never solve the accident problem until we adopt drivers' licensing regulations that will keep the incompetent and reckless driver off the public roads. No man has a "right" to drive until he can show definitely that he is worthy of the "privilege" bestowed upon him.

Mr. Magill: In my judgment this bill as drawn will cause a great deal more hardship than it is designed to correct, and so far as any provision of real highway patrol efficiency is concerned it amounts to about the same thing as a cipher with the rim knocked off.

Mr. Niewoehner: I vote "no" because the present economic condition of our state does not justify an increase of this extravagant patrol system. It is taxing all of our people to put a few men on a few favored highways.

Mr. Thompson: I intended to vote "no" on this bill until I heard Mr. Magill's remarks. He thought if we passed this bill we wouldn't be able to come back here two years from now, and after the rag-chewing that's been going on I think we would be doing the state a great favor in passing it. I vote "aye".

Mr. Hagen: I vote "aye" on this bill because while it is not perfect, I am inclined to worry more about the deaths of our citizens on the highways than small inconveniences which may be caused individuals violating traffic laws, however minor, which contribute, directly or indirectly, to serious accidents.

Dear Mr. Dahl:

You have asked for a ruling on Section 45 of the Constitution with reference to mileage and per diem for the members of the Legislative Assembly. Said Section 45 of the Constitution reads as follows:

"Each member of the legislative assembly shall receive as compensation for his services for each session, five dollars per day, and ten cents for every mile of necessary travel in going to and returning from the place of the meeting of the legislative assembly, on the most usual route."

Ordinarily the constitutional provision quoted would mean simply this—that each member is entitled to mileage at the rate of ten cents per mile from his home to Bismarck, and returning to his home on the most usual route. However, because of the peculiar circumstances in connection with the call for the extraordinary session, some of the members having already returned to their homes before the call was issued, while other members were still here, I am of the opinion that it would be just and equitable that each member should be allowed mileage from his home to Bismarck and return. While it is true that some of the members had not returned to their homes, nevertheless, I think it is entirely within the discretion of the Legislative Assembly to authorize the allowance of such mileage.

Mr. Traynor: There are a lot of things about this bill I do not like. I think it is working an injustice in some cases. However, I feel that if we remain here any longer to fight for amendments to the bill, we will be doing more damage than we would if we passed it. Therefore. I vote "aye."

Mr. Williams: I am going to vote "aye" on this bill, not because I think it is just, because the very first week we were here the House gave the Senate a leverage, and they are still using it, and this is one of their products. I vote "aye" on it. I hate to—it's a bitter pill.

Mr. Freitag: The reason I voted "aye" is not that I like this piece of legislation, but it appears that about nineteen Senators have got the whip in their hands and we are unable to procure any legislation that is just between the individual and corporations, and between the parties who are most able to pay the taxes.

Mr. Solberg: The reason I voted 'aye" on this bill is not that I like it. We are still satisfied, after we leave this session, to try to draw the majority of our taxes out of a dry hole, that dry hole being the farming and agricultural communities of the state, but due to the fact that we are quibbling and wasting money I would rather vote "aye" on this bill than stay here another ten days.

House Bill No. 2. A Bill for an Act Providing for the Appointment of a Superintendent of Divisions of Highway Safety and Patrol and Patrolmen and Employees; Providing for Operator's and Chauffeur's License and the

Fees to Be Paid Therefor and Providing for the Taking of Registration and Operator's and Chauffeur's License Applications; and Declaring an Emergency.

Which the Senate has amended as follows:

All amendments are on the printed bill.

- 1. After the word "Applications" in the title, strike out the period, insert a comma and add: "providing for the repeal of all conflicting Acts, declaring an emergency, and providing penalties for violation of this Act."
- 2. On page 3 at line 43, after the word "been," insert the words "three times".

Strike out the words "three minor offenses" and insert in lieu thereof "a misdemeanor under this Act or the laws of this state relating to highways".

- 3. On page 7, Section 7, line 2, strike out the words and figures "Seventy-five (75)" and insert in lieu thereof the words and figures "Fifty (50)".
- 4. On page 8 at line 9, strike out the words "seventy-five" and insert the words "fifty" in lieu thereof.

After the word "fee" in line 9, strike out the period and insert the following: "for such two year period".

- 5. On page 9, Section 9, line 3, strike out the language "minor offense" and insert in lieu thereof, "misdemeanor under this Act or the laws of this state relating to highways."
- 6. On page 12 in line 28, strike out the words "minor offenses" and insert in lieu thereof, "misdemeanors for violation of this Act or of any law of this state relating to highways".
- 7. On page 13 in line 6, strike out the word "the" and insert in lieu thereof the word "any".

Strike out the language, "of Burleigh County, North Dakota".

- 8. On page 13, Section 14, line 4, strike out the word "the" and insert in lieu thereof the word "any", and strike out the words "of Burleigh County".
- 9. On page 14, in Section 15, at line 8, after the word "General," insert the word "Highway," put a period after the word "Fund," and strike out the language "of the State Treasury".
- 10. In line 1, Section 16, strike out the words "SHERIFFS TO BE" and insert in lieu thereof "COMMISSIONER TO APPOINT"; strike out the following language in Section 16, "The sheriff of each county shall be appointed as local agent" and insert in lieu thereof "the Highway Commissioner shall appoint local agents".

- 11. In Section 17 on page 14, in line 3, strike out the words "the sheriff" and insert in lieu thereof "such local agent".
- 12. After the word "ACT" in line 5 of Section 17, strike out the balance of the Section.
- 13. On page 15, at line 14, strike out the word "twenty" and insert the word "fifteen" in lieu thereof.

On page 15, line 25, strike out the word "However" and the balance of the Section.

- 14. At line 36, on page 16, insert a new Sub-section (d) as follows:
- "(d) SALARIES, WAGES AND EXPENSES.) All salaries, wages and other expenses of the Division of Highway Safety and Patrol shall be paid by the State Auditor and State Treasurer out of the "Patrol Fund" herein provided, upon vouchers as now required by law for the payment of all state expenses, duly approved by the Commissioner and the Superintendent, and audited and allowed by the State Auditing Board. The salary of the Superintendent of the Division of Highway Safety and Patrol shall not exceed \$2,000 per annum, and the salary of the Assistant Superintendent shall not exceed \$1,800 per annum, the salary of each highway patrolman shall be fixed by the Superintendent at not to exceed \$125 per month, and shall be paid monthly out of the funds in the "patrol Fund", provided the salary of any appointee as patrolman shall not exceed \$100 per month for the first six months of employment."
  - 15. Add a new Sub-section (e) as follows:
- "(e) QUALIFICATIONS OF HIGHWAY PATROL-MEN.) All members of the Division of Highway Safety and Patrol shall not be less than twenty-five nor more than forty-seven years old on the date of their appointment. They shall before being qualified to appointment, be required to pass such physical examination and such other qualification test as may be determined by the Superintendent, be of good moral character and of temperate habits, have been citizens of the United States and of the State of North Dakota for not less than two years prior to their appointment. For appointment preference shall be given at all times to honorably discharged Veterans and all appointments shall be made without regard to any political party affiliation of the applicant."
  - 16. Add a new sub-section (f) as follows:
- "(f) POLICE AUTHORITY OF THE DIVISION OF HIGHWAY AND SAFETY PATROL.) The Commissioner and such officers and inspectors of the department as he shall designate and all members of the division of highway şafety and patrol shall have the power:
- "1. Of peace officers for the purpose of enforcing the provisions of this Act and of any other law regulating the operation of vehicles or the use of the highways.

- "2. To make arrests upon view and without warrant for any violation committed in their presence of any of the provisions of this Act or other law regulating the operation of vehicles or the use of the highways.
- "3. At all times to direct all traffic in conformance with law and in the event of a fire or other emergency or to expedite traffic or to insure safety to direct traffic as conditions may require notwithstanding the provisions of law.
- "4. When on duty, upon reasonable belief that any vehicle is being operated in violation of any provision of this Act or of any other law regulating the operation of vehicles to require the driver thereof to stop and exhibit his driver's license and the registration card issued for the vehicle and submit to an inspection of such vehicle, the registration plates and registration card thereon or to an inspection and test of the equipment of such vehicle.
- "5. To inspect any vehicle of a type required to be registered hereunder in any public garage or repair shop or in any place where such vehicles are held for sale or wrecking, for the purpose of locating stolen vehicles and investigating the title and registration thereof.
- "6. To serve all warrants relating to the enforcement of the laws regulating the operation of vehicles or the use of the highways.
- "7. To investigate traffic accidents and secure testimony of witnesses or of persons involved.
- "8. To investigate reported thefts of motor vehicles, trailers, and semi-trailers.
- "9. That said patrolmen shall be required to inspect all motor vehicles as to compliance with the provisions of law relating to the issuance and possession of motor vehicle licenses and to fully co-operate with the motor vehicle registrar in carrying out all of the laws relating to motor vehicle licenses, and to take over and perform the duties now performed by motor vehicle license inspectors under the Regulatory Department.
- "10. To take applications for driver's licenses without making charge therefor."
  - 17. Add a new sub-section (g) as follows:
- "(g) (a) The commissioner shall issue to each member of the division of highway safety and patrol a badge of authority with the seal of this State in the center thereof, the word 'North Dakota Highway Patrol' encircling said seal and below the designation of the position held by the member to whom issued. Every such badge shall be serial numbered or each member shall otherwise display a distinctive serial number.
- "(b) Neither the commissioner nor any other person shall issue any such badge to any person who is not a duly appointed and acting member of said division.

- "(c) Any person who without authority wears the badge of a member of said division, or a badge of a similar design which would tend to deceive anyone, is guilty of a misdemeanor.
