Bismarck, January 11, 1972

The Convention was called to order at 9:00 a.m., by President Wenstrom.

Prayer was offered by Rev. Richard Hagestuen, Pastor, First Lutheran Church of Mandan.

"Dear God,

"We ask your presence today in our individual lives as we deal with issues that concern the lives of many. We pray that Your will might be done individually and corporately. We see Your hand at work in the history of mankind, make us aware and desirous of that will which is Yours.

Delegate Hoffner moved that the amendments to Proposal 1-34 as recommended by the Committee on Legislative Functions and as printed on page 135 of the Journal be adopted, which motion prevailed.

INTRODUCTION OF COMMITTEE PROPOSALS

Committee on Finance and Taxation introduced:

Committee Proposal No. 1-87. Be it resolved by the North Dakota Constitutional Convention that article 56 of the amendments to the constitution of the state of North Dakota be repealed; and that a new section to the constitution of the state of North Dakota be created; both of which pertain to revenue from gasoline and motor vehicle registration and license taxes.

Was read the first time and referred to the Committee on Finance and Taxation.

Committee on Legislative Functions introduced:

Committee Proposal No. 1-88. Be it resolved by the North Dakota Constitutional Convention that sections 44, 51, 53, 54, 57, 59, 60 and 62 of Article II, section 199 of Article XIV and article 75 of the amendments to the constitution of the state of North Dakota be repealed.

Was read the first time and referred to the Committee on Legislative Functions.

FIRST READING OF PROPOSALS

Committee Proposal No. 1-19. Be it resolved by the North Dakota Constitutional Convention that section 210 of the constitution of the state of North Dakota be repealed; and that article IX to the constitution of the state of North Dakota be created; both of which pertain to appropriation of waters.
