2 the North Dakota Century Code, relating to printing duties
3 of the department of accounts and purchases.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE
6 STATE OF NORTH DAKOTA:

8 SECTION 1. AMENDMENT.) Section 46-01-02 of the North
9 Dakota Century Code is hereby amended and reenacted to read
10 as follows:

11 46-01-02. PRINTING DUTIES OF DEPARTMENT OF ACCOUNTS
12 AND PURCHASES.) The department of accounts and purchases
13 shall:

- 14 1. Draw up and examine all advertising and let all
15 contracts (((;))).
- 16 2. Examine all work and supplies (((for the purpose
17 of ascertaining whether the same))) to determine
18 if they conform to the contract (((;))).
- 19 3. Examine all accounts for (((public))) state
20 printing (((for the purpose of determining whether)))
21 to determine if the charges (((contained in such
22 accounts))) are correct (((;))).
- 23 4. (((Figure))) Determine the price of any legal
24 notice or publication when requested by any (((county

1 auditor or board of county commissioners, and
2 its))) state agency or department, or by any
3 political subdivision. Its decision ((as to be)))
4 on the proper fee for such publication shall be
5 binding and final, subject to review by the courts
6 ((; and))).

7 5. (((Perform such other duties in relation to print-
8 ing affairs as may be required by law))) Prepare
9 a legal publications handbook containing samples
10 of the legal advertising, legal notices, proceed-
11 ings, and other such items, including sample voting
12 machine and paper ballots, required of or published
13 by any state governmental entity or political sub-
14 division other than the judicial or legislative
15 branches of government. The handbook shall contain
16 guidelines for form, style, and content. The de-
17 partment shall prepare the handbook with the advice
18 of a committee composed of: the director of the
19 department; the director of the department's central
20 duplicating service; the secretary of state; the
21 president of the printing industries of North
22 Dakota; the president of the North Dakota newspaper
23 association; and the president of the North Dakota
24 county auditors association. The department shall
25 distribute the handbook to all concerned parties.
26 The department will determine if it shall approve
27 payments for any state agency or department, other
28 than the judicial or legislative branches of govern-
29 ment, advertising or publishing material not con-
30 forming with the handbook.
