

SUBJECT: Your request for revisions to Fiscal Note for SB 2240
as that bill may be affected by proposed amendments
to passenger fee schedule.

DATE: February 1, 1977

As proposed by the Highway Commissioner on January 25, the amendments to page 2, lines 16 through 22 of Senate Bill 2240 will affect the Fiscal Note which I submitted on January 19, 1977. If the amendments are adopted, the projected revenues to the Motor Vehicle Registration Fund generated by Senate Bill 2240 will be reduced from \$7,700,000 to \$6,500,000 for the 1977-79 biennium.

Senate Bill 2240 to be amended as follows:

On page 2, delete Line 16 through Line 22 and insert the following:
