FIRST DAY

Bismarck, January 6, 1981

At the hour of twelve o'clock noon on the sixth day of January, 1981, according to the Constitution of North Dakota, the North Dakota Senate convened in its regular session, President Pro-Tem Stanley Wright presiding.

The prayer was offered by Senator I. E. "Esky" Solberg.

"Our Heavenly Father, open our hearts and our minds to the great task before us. Help us to comprehend and to evaluate the many responsibilities confronting us. It is but two hundred years or more since our forefathers brought to us what became known by many as a great experiment. May it serve the providence that we have in doing the things that are essential to the development of our great state. Beyond the great imaginations of those who have read and studied before us the writings as well as the greatest of free documents, the Constitution of the United States could be possible to be able to define the meaning of freedom as we have it in this country. The undiscovered areas of our culture may be greater than we have thus far discovered. May the factor of the unknown then only individual enterprise can be a tool to develop the ideas and ideals that may confront us here. Help us in a manner becoming this body politic, help us to comprehend Your influence on this state and on its future. Help us to evaluate and always be mindful of Thy will. Help us to remember the great strength we possess as a body making laws. May Your hand of blessing rest heavily upon us as elected officials to the Senate of North Dakota. May You touch each of us seeming the great task before us. May we always recall that youth is a gift of nature, that age is a piece of art. Help us then by opening our hearts and our minds to the tasks before us in the many days ahead. Help us to evaluate these things that are important to the future of North Dakota and help us always in making wise decisions that shall be a benefit to all. In Thy name we pray, Amen".

ROLL CALL

The roll was called and all members were present except Senator Quail and the two vacancies.

A quorum was declared by the President Pro-Tem.

OATH OF OFFICE TO LIEUTENANT GOVERNOR

Senator Nething moved that a committee of two be appointed to escort the Honorable Justice Paul Sand of the North Dakota Supreme Court to the rostrum for the purpose of administering the Oath of Office to the Lieutenant Governor, which motion prevailed.

The President Pro-Tem appointed as such committee, Senators Lee and Reiten.

Senator Nething moved that a committee of two be appointed to escort Mrs. Ione Sands to the rostrum. The motion prevailed and the President Pro-Tem appointed as such committee, Sentors Wenstrom and Berube.

Senator Nething moved that a committee of two be appointed to escort the Honorable Ernest Sands to the rostrum for the purpose of receiving the Oath of Office as Lieutenant Governor of the State of North Dakota, which motion prevailed.

The President Pro-tem appointed as such committee Senators Nething and Redlin.

Chief Justice Sand then administered the Oath of Office to the Honorable Ernest Sands, Lieutenant Governor of the State of North Dakota, and Lt. Governor Sands then presided.

Lt. Governor Sands: Thank you, I appreciate that very much. When I received my certificate of nomination I said to my wife I didn't know whether I had won or lost. I felt that I had won the Lt. Governorship but I had lost my membership as a North Dakota Senator. It is an experience that I will always treasure and hold dear in my heart the memories of the many many sessions in this beautiful chamber. I value it and I am sure each and every one of you will value your experiences here in the North Dakota Senate. Thank you very very much.
