Any-such A coordination of benefits plan shall be approved by the commissioner of insurance."

REMARKS OF FORMER STATE

SENATOR CLAIRE SANDNESS

Mr. President, Members of the Senate, families and friends of those that we remember in a special way today. For this service, I want to bring to your attention one verse from the Gospel of Matthew, the 10th chapter by relating to you a lesson I learned from a friend of mine, a lesson that has helped me tremendously to understand what it means to serve in a public capacity, and to find in it, many ways to serve the Lord Jesus Christ.

"He that keeps his life for himself will lose it - but he who loses his life in Jesus Christ will find it there."

My friend said when he was in high school he learned a poem and he still remembers the first two lines because they bothered him so long. "Stone walls do not a prison make, nor iron bars a cage." I couldn't understand that, he said, because some time before that their class visited a state penitentiary on a field trip and it left a tremendous sensation - if those stone walls and iron bars don't make prisons, I don't know what does.

He said it was years before he understood what that poet was trying to say, and it came to him while reading a beautiful book about flying, entitled Wind, Sand and Stars, and in the final paragraphs of that book, you find these lines, the ones that straightened him out about what imprisons people, what enslaves people, what locks people in - not stone walls, not iron bars, but in the words of this author, Antoine de Saint Exupery. "What all of us want is to be set free. The man who sinks his pickaxe into the ground wants that stroke to mean something. The convict's stroke is not the same as the prospector's, for the prospector's stroke has meaning, and the convict's stroke has none. Prison is not just a mere physical horror. It is using a pickaxe to no purpose that makes a prison - a prison that we all yearn to escape.

I take this to mean that when you and I go along from day to day not understanding that who we are and what we do count how we have meaning in the whole scheme of human existence and God's plan, then we are imprisioned, then we are enslaved, then our life is without meaning.

If you forget everything else I say today, I want you to remember this - the thing that sets you free - gives your life meaning, significance, direction, structure, and force, is knowing that who you are and what you do from day to day makes a constructive difference.

Most all of the former Senators that we memorialize today were farmers, at least men close to agriculture, and they knew how to use a pickaxe and whether they would sink its point into the soil of their farm, or into the soil of government, or into the soil of community service, they wanted it to mean something and so do you!

Now one has to say that money is important. Too important to many. Because we have created the kind of world where hundreds of thousands of us believe it is enough to swing pickaxes for paychecks. Don't misunderstand me. We all know people who have their fair share of money, and perhaps more, who use it constructively and productively, and where they spend, where they invest - much of life lights up. But we also know those whose money is their dungeon. They spend their life counting it, guarding it, and ulcerating that the Federal Government or inflation, or a thief in the night will steal it away. So it is not so simple - to corner the so-called good things in life, and thus be free. And if I had the power to give people, out of my hand, the most precious of gifts, I shouldn't hand them sacks of gold and walk away.

But we must speak of another meaning of freedom for we have created the kind of world where hundreds of thousands believe that it is enough to swing pickaxesfor positions. And we think that when we get to be a foreman, a manager, a director, a Senator or whatever, then life will be a many splendored thing! I know we need leadership. We are so desperate for leadership in our land, in government, in industry, in labor, in education, in agriculture, in the church, and real leaders are rare. Too many seek only the power and prestige of the office and too few the hard, wearying, days and nights which really are the lot of leaders. You and I know some leaders who see their responsibilities not as a burden, but as an opportunity to swing their picks in meaning and in freedom. And where they lead, it's a joy to follow. But you and I also know others whose responsibilities as leaders are their dungeons. No happiness, only pressure, demands, no time of their own. So it is not so simple. And if I had the power to give everyone the most precious of human gifts. I wouldn't hand them a sack of gold or promise they'd get their name on any door.

For the thing that sets you free, that gives your life meaning, significance, direction, structure and force is knowing that who you are and what you do makes a constructive difference - whatever your level of affluence or leadership.

Jim Duncan had to learn that the hard and bitter way. I want to tell you his story.

I would like to nominate as my candidate as the greatest hero in WWII, Jim Duncan. He never wore a uniform, nor flew a bomber, nor stalked battleships in a submarine. The reason he didn't do any of these things throughout the war - he was serving a life sentence in the New Jersey State Penitentiary. We learned this story from the prison warden, John L. O'Hara. Jim Duncan was an honor student in high school. At 18 he was one of the finest golfers in the state of New Jersey, but like some young people both you and I know, thirsty for excitement, lost his way.

These were prohibition times and upon graduation from high school, he secured a very exciting job, piloting a rum-running speedboat off the New Jersey coast. One night they were hijacked and in the scuffle the hijacker was killed. Jim Duncan and his two companions were convicted of the murder and sentenced to life imprisionment in the New Jersey State Penitentiary.

Warden O'Hara reported that Jim Duncan served seven years of his time in obscurity. Then one day he asked to see the warden. He came into his office. He said nothing. He put a newspaper clipping on the warden's desk and he picked it up and read it. It told about a prisoner in the Connecticut Penitentiary who had just died after submitting himself as a volunteer in an Army medical experiment conducted in that prison.

Why can't we do something like that, Duncan asked. What do you mean die, the warden asked. Do you think that the men would volunteer, he continued. I think they would gather around like flies, Duncan answered. O'Hara, haunted by this strange request, called the Surgeon General's Office to inquire about the need for human volunteers in Army medical experiments and discovered it was very urgent. So he set up an experimental ward in the prison hospital. The Army medics came in and called first for volunteers for sleeping sickness. Jim Duncan was the first to volunteer!

Next came sandfly fever. This was the disease that killed so many of Rommel's men in the African desert - again Jim Duncan was the first to volunteer.

Later he was one of 16 to be inoculated with dengue-fever, the fever that caused more casualties in the Pacific than the Japanese. O'Hara watched these volunteers suffer terribly. Duncan's weight dropped from 174 to 140 pounds, but he no sooner was back on his feet when he volunteered a second time for further dengue-fever experiments. The warden said he watched these men, and especially this kid, Jim Duncan, and wondered if he would live. Why should he, condemned by society to spend the rest of his life behind stone walls and iron bars, so freely endanger his life for people for whom he should never meet or know that they might be saved from pain - even death?

Towards the end of the war, he got his answer.

Jim Duncan had volunteered the fifth time as a human guinea pig, this time for transfusion jaundice. It was reported that a prisoner in

another prison had just died in such an experiment. Coming into the hospital ward this night, O'Hara saw Duncan on his cot, pale, terribly high fever, a deathly sick man. And though he had his eyes closed, O'Hara knew he was awake. And he said to him, Jim, I'm going to level with you. This time you are bad. You may not live through this. Is there anything you want me to do for you?

After what seemed to be an eternity, Duncan said, "No, I'm fine. I'm very fine. I have never been better in my whole life."

Why have I told you this story? Because I want you to possess Jim Duncan's secret. Because I want to underline the involvement of a person with a purpose, and now it transformed him and transformed the lives of countless others. And because so many forces in our world today teach quite another lesson—to go it alone. A recent best seller, "Looking Out for Number One", another "Winning by Intimidation", it's alright if you can do it.

This resounding message of much of the adult world (to our youth in our time) is what Jim Duncan once believed. He was a bright boy, a gifted child. Well educated in a sense. Apparently it never occurred to those responsible for his education that it was not his academic record, it was not his mental alertness, nor his fund of information, nor his athletic skill, rather it was the nature of the gods he chose to serve with all he was.

Jim Duncan at the age of 25 came to understand that his life really had no meaning unless somehow, some way, he could tie it back into the lives of other people.

In prison, to lie in solitary confinement is the cruelest of punishments. But outside of prison, to make oneself the center of all one's concern and endeavor, to go it alone, taking care of No. 1, to win by intimidation—these are equally as corrupting and corroding of the human spirit.

For when the purpose of people are intimidation and exploitation, they, as well as the exploited, are diminished. But when the purpose of people are to serve, both they and those they serve are enriched and transformed.

After the war, Jim Duncan was paroled. He is today an editor of a newspaper in the State of Alaska.

But I should like to point out that he really won his freedom, not the day he walked through those prison gates and into the world again, but rather at that moment back in prison when he came to understand the necessity to swing his pick in the community of mankind.

When he came to understand the necessity to join the greatest of all communities—to join the human race! "He who keeps his life for himself shall lose it".

Jim Duncan strengthened and sustained by God offered his life to community of people and there he found it again. My dad, like all these former Senators that have died, that we remember today, I'm sure gave most all his life to his family—and hardly a day goes by—in something that I do, or something that I think about—I find him there!

They gave a part of their life to the North Dakota Senate—and this afternoon we find them again!

Go forth into the world in peace. Be of good courage, hold fast to that which is good, and render unto no man evil for evil. Strengthen the fainthearted, support the weak, help the afflicted, honor all men. Love and serve the Lord, rejoice always in the power of God's Holy Spirit. Amen.
