WHEREAS, Brynhild Haugland was first elected to the North Dakota House of Representatives in 1938 and has served since that time as a state representative, which is the longest service as a state representative of anyone currently serving in that capacity in the United States; and

WHEREAS, Representative Haugland has served as chairman of the House Committee on Human Services and Veterans Affairs during 20 of her 25 legislative sessions of service; and

WHEREAS, her many legislative accomplishments include enabling legislation for multicounty health units, establishment of the North Central Experiment Station, child abuse reporting requirements, authority to parole eligible Industrial School students to foster homes, and enabling legislation for opening San Haven to patients from the Grafton State School; and

WHEREAS, her accomplishments outside the legislative arena include service as a member of the board of directors of the International Peace Garden since 1953, membership on the board of the State University of North Dakota-Minot Alumni Association and College Foundation, charter membership in the Eureka Homemakers Club, and membership in the Quota Club, Minot Business and Professional Women's Club, Delta Kappa Gamma, Farm Bureau, and Farmers Union and membership on the Ward County Zoning Commission and on the Minot Planning Commission; and

WHEREAS, recognition for her accomplishments include Minot State College Alumni Golden Award for Outstanding Service, Sertoma's Service to Mankind Award, the North Dakota Public Health Association's Merit Award for Outstanding Service to Public Health, the State Bar Association's Liberty Bell Award, and the North Dakota Mental Health Association's Distinguished Service Award; and

WHEREAS, her achievements are self-described as "any good thing can be accomplished if you aren't particular about who gets the credit";

WHEREAS, among her many legislative accomplishments are establishment of the North Central Experiment Station, authority to parole Industrial School students to foster homes, and child abuse reporting requirements, as well as enabling legislation for multicounty health units and opening San Haven to patients from the Grafton State School; and WHEREAS, her public service includes being a member of the Ward County Zoning Commission, Minot Planning Commission, Board of Directors of the International Peace Garden, Quota Club, Business and Professional Women's Club, Board of Directors of the State University of North Dakota-Minot Alumni Association and College Foundation, Delta Kappa Gamma, Farm Bureau, Farmers Union, and the National Retired Teachers Association, as well as being a charter member of the Eureka Homemakers Club and the vice president of the International Peace Garden, Inc., and being named an honorary member of the Uniformed Fire Fighters of North Dakota in 1976; and

WHEREAS, recognition for her accomplishments include receiving Minot's Woman of the Year for 1956 and 1971, the Minot State College Alumni Gold Award for Outstanding Service 1968, the North Dakota Outstanding "Woman in Law" in 1973 from the North Dakota Women's Coalition and the North Dakota Commission on the Status of Women, the Milky Way Award in 1977 in recognition of outstanding contributions to the dairy industry of the state, the Distinguished Service Award 1977-1978 from the Western North Dakota Health Systems Agency, the North Dakota Water Wheel Award in 1981 from the North Dakota Water Users Association and the North Dakota Water Management Districts Association, Sertoma's Service to Mankind Award in 1983, the Merit Award for Outstanding Service to Public Health in 1983 from the Public Health Association of North Dakota, the Liberty Bell Award in 1983 from the State Bar Association, the Distinguished Service Award in 1983 from the Mental Health Association of North Dakota, the Honorary Recognition Award in 1983 from the State Nurses Association of North Dakota, the Minot Association of Homebuilders Award for Outstanding Contributions to the Building Industry in 1984, and induction into the Scandinavian Hall of Fame in 1984; and

WHEREAS, her accomplishments need to be recognized in an appropriate manner so as to inform the citizens of the state of her dedication to public service; and

WHEREAS, public meeting rooms in the State Capitol have been named in recognition of personages having important roles in this state's history;

# SENATE AMENDMENTS TO ENGROSSED HB 1079

On page 1 of the engrossed bill, line 26, delete the word "<u>one</u>" and insert in lieu thereof the word "<u>two</u>" and delete the words "two hundred" And renumber the lines, sections, and pages accordingly

SENATE AMENDMENTS TO ENGROSSED HB 1350

- On page 4 of the engrossed bill, line 16, delete the words "Except as otherwise" and insert in lieu thereof the words "Before it may offer insurance in any state, each risk retention group shall also submit for approval to the insurance commissioner of this state a plan of operation or a feasibility study and revisions of such plan or study if the group intends to offer any additional lines of liability insurance. Immediately upon receipt of an application for charter in this state the risk retention group shall provide summary information concerning the the national association of insurance filing to commissioners including the name of the risk retention group, the identity of the initial members of the group, the identity of those individuals who organized the group who will provide administrative services or otherwise or influence or control the activities of the group, the amount and nature of initial capitalization, the coverages to be afforded, and the states in which the group intends to operate. Providing notification to the national association of insurance commissioners is in addition to and is not sufficient to satisfy the requirements of this Act."

- On page 5 of the engrossed bill, after line 2, insert the following new subdivision:
  - "ь. Α copy of its plan of operation or a feasibility study and revisions of such plan study submitted to its state of domicile; or provided, however, that the provision relating to the submission of a plan of operation or a feasibility study does not line apply with respect to any or classification of liability insurance which was defined in the Product Liability Risk Retention Act of 1981 before October 27, 1986, and was offered before such date by any risk retention group which had been chartered and operating for not less than three years before such date."
- On page 5 of the engrossed bill, after line 24, insert the following new subsection:
  - "3. Taxation.
    - a. All premiums paid for coverages within this state to risk retention groups are subject to taxation at the same rate and subject to the

same interest, fines, and penalties for nonpayment that are applicable to foreignadmitted insurers.

- b. To the extent agents or brokers are utilized, they shall report and pay the taxes for the premiums for risks which they have placed with or on behalf of a risk retention group not chartered in this state.
- c. To the extent the agents or brokers are not utilized or fail to pay the tax, each risk retention group shall pay the tax for risks insured within the state. Further, each risk retention group shall report all premiums paid to it for risks insured within the state."

"SECTION 11. Duty of agents or brokers to obtain license. Any person acting, or offering to act, as an agent or broker for a risk retention group or purchasing group, which solicits members, sells insurance coverage, purchases coverage for its members located within the state, or otherwise does business in this state, shall, before commencing any such activity, obtain a license from the

# REMARKS BY GOVERNOR GEORGE A. SINNER

My distinguished colleague Brynhild, Mr. Speaker, Mr. President Pro Tem, Governors Link and Guy and Davis, distinguished members of the Senate and the House, distinguished public officials, ladies and gentlemen:

Brynhild, I have always admired you for your intelligence. You have perceived the truth much more quickly than most of us. Intuitively almost, you have seen fraud and phony and fictitious fanfare for what it was. You have always, with your intelligence, seen clearly and spoken clearly.

I have always admired you for your humility, too. Someone described humility as the awareness of what one knows and the awareness, as well, that others know things, too. You have done both.

Brynhild, I have admired you, as well, for your courage. You have never feared to speak your mind, to act, knowing always as all people of action know, that you could err, that you could even be thought a fool, but you have humbly trusted your intelligence and you have spoken and you have acted and you have done much for all of us.

Finally, Brynhild, I have admired your patriotism. You have never put person nor party nor profit ahead of public good. You have worked for the people at every turn. You have been the true patriot who has been willing to say over and over again that it is the people that count, not the party or person. Brynhild Haugland, you are a model for all of us and, on behalf of all the people of this state, I thank you.

I would like to present to you an engraved copy of the proclamation which states, in proclamation form, the wonderful things that the resolution you have just heard says about you. I hope it reminds you that the people of the state are grateful and they always will be. Thank you very much.

# REMARKS BY CHIEF JUSTICE RALPH J. ERICKSTAD

I thank you, President Pro Tempore Rolland Redlin, Speaker of the House Richard W. Kloubec, Governor George Sinner, former Governors John Davis, William Guy, Arthur Link, and Allen Olson, leaders of the Republican and Democrat caucuses of the House and Senate, committee chairpersons, other members and staff of the Fiftieth Legislative Assembly, my colleagues on the Supreme Court and other state officials, other distinguished guests, colleagues and friends of our honored guest and good friends of state Representative Brynhild Haugland, ladies and gentlemen.

It is a great privilege and pleasure for me to be asked to participate in this much deserved recognition of our friend Brynhild Haugland. It is my understanding that her tenure as a current legislator is unmatched in this country today, but more than that it is highly unlikely that her contributions as a member of this House of Representatives to the people of our state for almost fifty years will ever be matched.

In preparation for my small part in today's ceremonies, I asked my law clerk to check the legislative journals and bill books to find representative pieces of legislation that Brynhild sponsored in each of the legislative sessions that she has served since 1939. Although I will not attempt to summarize what he has compiled for me which is contained in this notebook, I thought it might be appropriate to present this notebook and its contents to Brynhild today so that she might use it when she feels inclined to think back over her long and illustrious career. It will serve only as a sample of her contribution to the law of this state for the benefit of the people of this state, many of whom may have lost their cause without Brynhild Haugland.

Brynhild, at the close of my remarks I will present this notebook to you with the hope that a perusal of its content might bring to mind many of your successful endeavors as a legislator for almost half a century.

In addition to this effort to learn more about Brynhild, I read copies of the numerous newspaper articles filed with the Legislative Council which tell of the many occasions at which Brynhild Haugland has been recognized and honored for her numerous contributions and accomplishments over the many years. Because I believe that most of you are cognizant of those honors and it is likely that other speakers here today may refer to them, I shall not enumerate them, notwithstanding that they are numerous and significant.

What I have decided to do for my part here today is to reminisce just briefly with you over my experiences and contacts with Brynhild Haugland while I served in the Legislature over a quarter of a century ago.

I came to the Senate in 1957, and, to the best of my knowledge, there is not one person left in the Senate today who was there in 1957. It is also my impression that there is not anyone left in the House other than Brynhild Haugland who was there in 1957. I realize that our friend Bryce Streibel started in the House in 1957, took a sabbatical, and then was elected to the Senate and is there today.

In any case, I was fortunate to be appointed to the Legislative Council which was then called the Legislative Research Committee, and, in conjunction with that appointment, I was named the chairman of the Legislative Organization and Procedure Committee which was established to make a complete study of all aspects of legislative organization and procedure in the language of the resolution, and I quote: "a result of the growth of modern government and the increasingly complex problems with which the Legislative Assembly must deal in the hundreds of bills placed before it at every session."

Just to give you a flavor of the members of the committee who are no longer members of the Legislature, let me read to you the names of the other members of the committee, namely: Senators Ralph Dewing, Gail Hernett, Donald C. Holand, and Frank A. Wenstrom, and Representatives Howard F. Doherty, Louis Leet, Norbert Muggli, and Gorden Paulson. The report of our committee is included in the report of the Legislative Research Committee to the Legislature in 1959. τf you will read that report some time at your leisure for historic reasons, you will find that you have come a long way since then in improving the legislative processes.

Back in 1959, our problems then involved, among other things, the sixty-day limitation in the Constitution for legislative sessions. At that time, pursuant to custom, Sundays were counted as work days although no work was done on Sundays, and thus the session was only about fifty-one days in duration. The committee recommended, and the Legislature ultimately embraced, the idea of not counting Sundays as working days and, accordingly, about nine additional days were secured thereby.

In order to gain some additional time for legislation, the committee also recommended that the members of the Legislature convene in December of the year preceding the regular session of Legislature for a three-day presession informal the organizational session. The concept was contained in Senate Bill 51. It passed the Senate, but died in the House when Brynhild moved adoption of the report of the State and Federal Government Committee that it be indefinitely postponed. Brynhild opposed it, believing it to be a political gimmick designed to provide for political activity at state expense.

Ultimately, we were able to convince Brynhild and others that it should be given a chance and the concept was first tried out through legislation and, of course, you know today it is a part of our Constitution, having been approved by the people.

Another instance in which I learned the quiet strength of Brynhild was in conjunction with an appropriation bill affecting the State Industrial School then known as the State Training School.

Brynhild has always been a great supporter of projects and bills that would help the underprivileged and less fortunate people and, of course, that means that she has always had a soft spot in her heart for the children at the State Industrial School.

Before I relate to you this incident -- which further convinced me of Brynhild's strength, determination, and effectiveness as a legislator--I should point out that in the summer of 1959, there had occurred an incident at the State Industrial School wherein it was alleged that four boys had been shackled together in a room in old "Brown Cottage" for a number of days under trying circumstances for having run away. The incident resulted in an investigation by the State Board of Administration, which in those days had the responsibility for administering the Industrial School and the appointment of its superintendent.

Following the hearing, and in conjunction with the appropriation for the Industrial School in the 1961 Legislative Assembly, some

concerned persons, including Brynhild, were convinced that one of the things that was needed on the campus was a chapel which the students could utilize for prayer and meditation. Funds for a chapel were included in House Bill 507 by amendment of the Industrial School Bill in the House and the bill was sent to the Senate. When this bill reached the Senate Appropriations Committee, of which I was a member, I suggested, having attended the hearings in conjunction with the investigation of the incident involving the shackling, that we eliminate the chapel and use the funds for the replacement of old "Brown Cottage," which some said was a firetrap and where the boys had been shackled together, with a new dormitory which would have better security and which would permit the containment of students without shackling. Accordingly, the Senate took out the funds for the chapel and put in the funds for the replacement of "Brown Cottage." That resulted in a conference committee, which did not include Brynhild by name but was influenced by her feeling of a need for a chapel for the children.

After one or two meetings of the conference committee, I could see that the House members were not going to budge on the chapel so I suggested that perhaps the State could afford both the replacement of "Brown Cottage" for \$100,000 and the construction of a chapel for \$70,000. This was agreed to and we signed and sent a report to that effect to our respective houses. Both houses agreed to the conference committee report, and, as a result, the Industrial School and its children benefited through Brynhild Haugland's low key, but forceful, influence.

I am sure that there are many other instances we could relate that would show how Brynhild Haugland's determination and courage have resulted in legislation benefiting the people of our State.

Although I have related a couple of incidents in which you were a formidable adversary while I served in the Legislature, Brynhild, there are many occasions which I could point to since I have been in the Judiciary when you have been an ally and a supporter in our efforts to improve the judicial system and for that I thank you on behalf of the entire Judiciary.

I hope that you will be able to continue to serve as a State Legislator for years to come. At the very least, I hope you will continue to serve as long as it is my duty to serve in my present capacity for, without your help, I know that my task would be made much more difficult. I thank you, Brynhild, for what you are and for all that you have done for all of us.

Minot's State University, and all of higher education, owes much to the leadership of Representative Haugland.

Remarks on your splendid career are not complete without reference to your superb political acumen. You have given all of us political lessons and you have helped our young people to admire the field of politics and recognize the importance of political action to an effective democracy.

This legislature and all of North Dakota says thank you, Representative Haugland, and extends to you our best wishes.

People are being elected to the legislature at a much younger age. These young people contribute much to the enactment of good legislation.

To me, the legislative process has been most gratifying when we have been able to factor out the irrelevant and find that common ground which yields the legislation which best serves the people of North Dakota. Obviously, this is not an individual effort but a cooperative effort enhanced by leadership in both parties.

Although this has been an occasion where we have enjoyed looking back, it is equally important that we look to the future--to the 100th anniversary of statehood and to continued progress.

Thank you all very much, Governor Sinner, Chief Justice Erickstad, Senator Redlin, Father McKanna, Peace Garden Board of Directors, and all who planned and participated in this program. Thank you for this honor.
