REMARKS

by

Arthur A. Link, Chairman North Dakota Centennial Commission

Thank you for allowing me the opportunity and the honor of speaking here today. I bring you greetings from the seventeen members of the North Dakota Centennial Commission, four of whom are members of the Legislature. As chair of the Centennial Commission for the past two years, I have presided over the efforts of these volunteer members and others in planning and organizing for the celebration of one hundred years of statehood in 1989. A great deal has been accomplished, but much has yet to be done to ensure that North Dakotans will be ready to seize this opportunity that comes only once in a lifetime.

What we refer to when we talk about the centennial is a period of time. It will be one hundred years that North Dakota has been a state. That, in itself, is not a cause to celebrate. Time will march on with or without our notice. But, as a people we have learned that our roots and the values we have acquired from the past are the foundation upon which to build for the future. So, we have a tradition of taking stock, of sizing up ourselves and our situation. And, with a centennial, the inclination is very strong. The number 100 is a positive symbol in our society: a symbol of success and achievement.

It is when that moment and the inclination come together that a wonderful opportunity presents itself to us.

So the question is, what will we do with this opportunity?

All of you here today understand this. You and your predecessors were keenly perceptive in creating the Centennial Commission in 1981, to start the planning, to get the people thinking, and to create the organizational systems necessary to make this a time of growth in understanding and growth in state pride for North Dakota. Most of you here today were present to give support in previous legislative sessions to lay the groundwork for a centennial which goes beyond the expected celebrating to achieve cultural, economic, and human enrichment.

And now, you are to be commended again for your work during this legislative session. You have amended a 1985 measure making it legal to display the centennial license plate on vehicles immediately. You have passed a series of resolutions establishing the significant days of statehood commemoration in 1989. You have passed two bills making it more convenient for city and county centennial committees and state agencies to carry out projects in the name of the centennial. And, many of you, as individuals, have responded enthusiastically to our invitation to become involved in a centennial speakers bureau.

Yours have indeed been significant and timely contributions. But the real buildup to the centennial is still ahead. We are just now entering the critical period of time for precentennial planning. In the timetable of events it has already been established that North Dakota will officially begin observing the centennial on November 2, 1988. By the time of your next assembly during the first three months of 1989, the centennial will be underway.

Right now, thousands of North Dakota citizens are in the midst of organizing centennial committees. Their primary goal will be to conduct projects of lasting importance in the community.

As an indication of the broad interest already developing, you will find in the report before you applications of some of the ninety-seven projects already started for the centennial. Many have local and regional importance. Some have statewide significance, such as the All Veterans Memorial to be erected on the Capitol grounds; the North Dakota Hall of Fame; a Centennial Band; a living history farm at Fort Ransom; the world's largest quilt; and the restoration of historic buildings, such as Lawrence Welk's birthplace at Strasburg, the Carroll House in Fullerton, or the Armory in Williston.

The people associated with these and all the projects are proud to be working on the centennial . . investing their time and talent and, yes, their own money to make a lasting contribution to the State of North Dakota. They need encouragement during this time when the inclination is strong. They need to know that the state shares their enthusiasm.

Some projects on this list and many more yet to come will need the support of a matching grant program in the next two years. The Centennial Commission and staff are committed to establishing criteria to maximize participation at the local level to achieve lasting results.

Our activities are not confined to North Dakota. South Dakota, Montana, and Washington also observe centennials in 1989. Idaho and Wyoming celebrate in 1990. At regional meetings, ideas have been shared and plans are being made for multistate projects in this historic, northwest region of the country. A particular goal will be to publicize tourism. The experience of working together in the name of the centennials will be the foundation for a permanent tourism and economic development program involving all six states. This adds a new dimension to the importance of our centennial observance.

Before I close, I would be remiss if I did not make a recommendation for your consideration. At the Centennial Commission we are constantly encouraging groups and organizations to get involved and start planning. Although the Legislature has been involved right from the start, you may not as yet have planned for events you may wish to conduct two years from now during the centennial year legislative session.

The Centennial Commission would welcome the opportunity to assist a special committee or a standing Legislative Council committee in planning for special centennial ceremonies and observances during and after the Fifty-first Legislative Session. Legislative history goes right back to day one of North Dakota statehood, and few public bodies have a greater tradition to learn from and commemorate than the Legislature.

I relinquish the floor with grateful thanks to you and the fine members of this body.
