1. Please estimate the fiscal impact (in dollar amounts) of the above measure for state general or special funds, counties, and cities.

Narrative: The bill legalizes the conduct of games of chance through electronic video gaming devices. The bill sets a limit on site rental; eliminates the game of paper charitable gaming tickets except when conducted through electronic-mechanical dispensing devices; requires manufacturing standards and testing and approval of video gaming devices; and requires a computer telecommunications and management information system. The bill allocates adjusted gross proceeds between gaming tax, expenses and eligible uses; requires licensing of manufacturers, distributors, and video gaming devices; and requires background investigations of applicants. The bill provides an appropriation of \$2,000,000 and 5 full-time equivalent positions to the attorney general's office.
