Narrative:

House Bill No. 1511 brings nonprofit health service corporations, e.g., Blue Cross Blue Shield, into the membership of the Life and Health Insurance Guaranty Association. This would result in nonprofit health service corporations licensed in this state sharing the cost of insolvencies of other health insurers. The total cost of insolvencies are ultimately borne by the State of North Dakota through premium tax credits allowed Guaranty Association members for assessments paid.

2. State fiscal effect in dollar amounts: This bill would not increase the total cost, it simply spreads 1995-97 it among more members
