- 1. Please estimate the fiscal impact (in dollar amounts) of the above measure for state general or special funds, counties, and cities.

Narrative:

*SB 2522 was introduced at the request of North Dakota aquaculture producers. SB 2522 will add a new chapter to Title 4 of the North Dakota Century Code and creates new responsibilities for the Department of Agriculture. The Department of Agriculture will try to consolidate aquaculture functions with dairy and poultry. The department's budget provided for an FTE in the dairy division which could staff this program, but did not request operating funds. The department budget should include an appropriation to provide the services requested. Attached are projected figures for the 1993-95 biennium and the 1995-97 biennium. The amendments to SB 2522 have no fiscal impact.*
