- 1 A BILL for an Act to create and enact a new section to chapter 16.1-01 of the North Dakota
- 2 Century Code, relating to the designation of early voting locations; to amend and reenact
- 3 sections 16.1-07-01, 16.1-07-05, 16.1-07-06, and 16.1-07-08 of the North Dakota Century
- 4 Code, relating to an elector's eligibility to vote by absentee ballot; and to repeal section
- 5 16.1-07-02 of the North Dakota Century Code, relating to voting by absentee ballot.

## 6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7 **SECTION 1.** A new section to chapter 16.1-01 of the North Dakota Century Code is 8

created and enacted as follows: Early voting permitted - Secretary of state shall adopt rules. The board of county

10 commissioners of a county may permit a qualified elector of that county to vote an early voter's

11 ballot at the county auditor's office during regular business hours or at any other location

12 designated by the board of county commissioners for up to fifteen days before any election. A

13 qualified elector who appears at an early voters' polling place during the time designated by the

board of county commissioners may cast a ballot in the same manner as any ballot would be

cast at a regular polling place on election day. Notwithstanding any other provision of law, the

secretary of state shall adopt special rules regarding the appointment of election officers for

early voters' polling places, the counting of early voters' ballots, and any other necessary

18 procedures for the implementation of early voting.

SECTION 2. AMENDMENT. Section 16.1-07-01 of the North Dakota Century Code is amended and reenacted as follows:

21 16.1-07-01. Absent voter - Who may vote.

> Any qualified elector of this state, including an individual who, at any general, special, or primary state election, at any county election, or at any city or school district election, is absent from the city, township, or consolidated voting precinct in

1		which he is an elector, is in the armed forces of the United States, is in the	
2		merchant marine of the United States, is physically disabled, or is a United States	
3		citizen living outside the United States who resided in this state immediately prior	
4		to his the individual's departure from the United States, may vote an absent voter's	
5		ballot at that any general, special, or primary state election, any county election, or	
6		any city or school district election.	
7	2.	A qualified elector who is a citizen of the United States and lives outside the United	
8		States may vote absentee in this state pursuant to this chapter if he the individual:	
9		a. Does not maintain a domicile;	
10		b. Is not registered to vote;	
11		c. Is not voting in any other state, territory, or possession of the United States;	
12		and	
13		d. Possesses a valid passport or card of identity and registration issued under	
14		the authority of the secretary of state of the United States.	
15		Such an elector may vote only in federal elections, which means any election held	
16		solely or in part for the purpose of electing or nominating any candidate for the	
17		office of president, vice president, presidential elector, member of the United	
18		States senate, or member of the United States house of representatives.	
19	<u>3.</u>	An elector who votes by absentee ballot may not vote in person at the same	
20		election.	
21	SECTION 3. AMENDMENT. Section 16.1-07-05 of the 1995 Supplement to the North		
22	Dakota Century Code is amended and reenacted as follows:		
23	16.1	-07-05. Time for applying for ballot. At any time in an election year, any qualified	
24	elector exp	ecting to be absent on election day as provided in section 16.1-07-01 may apply to	
25	the county a	auditor, the auditor or clerk of the city, or the business manager of the school district,	
26	as the case may be, by facsimile or otherwise, for an official ballot to be voted at that election.		
27	A voter may	obtain an application form for an absent voter's ballot for a general, special,	
28	primary, or county election from either the county auditor or a city auditor. The application form		
29	for a member of the United States armed forces or the United States merchant marine or for a		
30	qualified ele	ector living outside the United States, must include a space for the applicant to	
31	indicate wh	ether the application is for all statewide elections in the calendar year or only for the	

1 election that is immediately after the date of the application. An applicant who is a member of 2 the United States armed forces or the United States merchant marine or is a qualified elector 3 living outside the United States, may apply for and vote by facsimile if otherwise qualified to 4 apply for and vote by absentee ballot. An auditor, clerk, or business manager may send and 5 receive facsimile absentee ballot applications and facsimile absentee ballots to those electors 6 any individual eligible to apply for and vote by facsimile under this section. No auditor or clerk 7 may issue ballots for absentee voters on the day of the election. 8 **SECTION 4. AMENDMENT.** Section 16.1-07-06 of the 1995 Supplement to the North 9 Dakota Century Code is amended and reenacted as follows: 10 **16.1-07-06.** Application form. 11 Application for an absent voter's ballot must be made on a blank furnished by the 12 proper officer of the county, city, or school district in which the applicant is an 13 elector, or on any blank containing the following information: 14 The applicant's name. a. 15 b. The applicant's voting address. 16 The applicant's mailing address. C. 17 d. The applicant's current home telephone number. 18 e. The election for which the ballot is being requested. 19 f. The applicant's reason for voting absentee as specified in section 16.1-07-01. 20 The date of the request. <del>g.</del> 21 An affirmation that the applicant has resided in the precinct for at least thirty <del>h.</del> g. 22 days. 23 ÷ h. The applicant's signature. 24 2. A qualified elector absent from the state is not required to file an application for an 25 absent voter's ballot for any statewide election if either of the following apply: 26 The elector is a member, or spouse or dependent of a member, of the United a. 27 States armed forces or merchant marine. 28 The elector is a United States citizen living outside the United States. b. 29 If the qualified elector furnishes the county auditor with a current mailing address 30 and the elector's local residence or precinct, the county auditor shall mail to the

qualified elector a ballot with a return envelope and instructions for voting for any 2 statewide election in that calendar year.

SECTION 5. AMENDMENT. Section 16.1-07-08 of the 1995 Supplement to the North Dakota Century Code is amended and reenacted as follows:

16.1-07-08. Delivering ballots - Envelope accompanying - Statement on envelope - Inability of elector to sign name.

- Upon receipt of an application for an official ballot properly filled out and duly signed, or as soon thereafter as the official ballot for the precinct in which the applicant resides has been prepared, the county auditor, city auditor, or business manager of the school district, as the case may be, shall send to the absent voter by mail, at the expense of the political subdivision conducting the election, one official ballot, or personally deliver the ballot to the applicant or the applicant's agent, which agent may not, at that time, be a candidate for any office to be voted upon by the absent voter. The agent shall sign the agent's name before receiving the ballot and deposit with the auditor or business manager of the school district, as the case may be, authorization in writing from the applicant to receive the ballot or according to requirements set forth for signature by mark. No person may receive compensation, including money, goods, or services, for acting as an agent for an elector, nor may a person act as an agent for more than four electors in any one election. A voter voting by absentee ballot may not require the political subdivision providing the ballot to bear the expense of the return postage for an absentee ballot.
- 2. If there is more than one ballot to be voted by an elector of the precinct, one of each kind must be included and an envelope must be enclosed with the ballot or ballots. The front of the envelope must bear the official title and post-office address of the officer supplying the voter with the ballot, and upon the other side a printed statement in substantially the following form:

1	I,, under penalty of possible criminal prosecution for making a false	
2	statement, do solemnly swear that I am a resident of the township of, or	
3	of the precinct of the ward in the city of, residing a	
4	in said county, the county of and state of North Dakota, and	
5	entitled to vote in such precinct at the next election; that I expect to be absent from	
6	the precinct of my residence on the day of the election or that by reason of physic	
7	disability I am unable to attend at the polling place for the election, and that I will	
8	have no opportunity to vote in person on that day.	
9		
10	If the absent voter is unable to sign the voter's name, the voter shall mark (X) that	
11	statement in the presence of a disinterested person. The disinterested person	
12	shall print the name of the person marking the X below the X, and shall sign that	
13	person's own name following the printed name with the notation "witness to the	
14	mark".	
15	SECTION 6. REPEAL. Section 16.1-07-02 of the North Dakota Century Code is	
16	repealed.
