3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4	SECTION 1. APPROPRIATION. The funds provided in this section, or	so r	nuch of the
5	funds as may be necessary, are hereby appropriated out of any moneys in the	gene	eral fund in
6	the state treasury, not otherwise appropriated, and from special funds derived from special funds deri	om.	federal
7	funds and other income, to the adjutant general's office for the purpose of defra	ying	the
8	expenses of the adjutant general's office, for the biennium beginning July 1, 199)7, a	and ending
9	June 30, 1999, as follows:

1	SECTION 2. SPECIAL FUNDS. The amount of \$60,000, or so much of the amount as
2	is necessary, included in the estimated income line item in section 1 of this Act, is to be spent
3	from the national guard tuition trust fund for the tuition programs provided for in chapters
4	37-07.1 and 37-07.2 for the biennium beginning July 1, 1997, and ending June 30, 1999.
5	SECTION 3. APPROPRIATION. There is hereby appropriated any funds received by
6	the adjutant general from federal and private sources for the purpose of operating the North
7	Dakota veterans' cemetery at or adjacent to Fort Abraham Lincoln state park for the biennium
8	beginning July 1, 1997, and ending June 30, 1999.
9	SECTION 4. ARMORY REPAIR AND MAINTENANCE GRANTS. The adjutant
10	general shall distribute the armory repair and maintenance grants on an equal matching basis
11	of up to \$15,000 per city to cities that own armories utilized by the North Dakota national guard.
12	After June 30, 1998, the adjutant general may distribute any remaining uncommitted funds on a
13	matching basis to eligible cities for qualified projects exceeding the \$15,000 equal match
14	requirement. No funds may be distributed to a city unless the city has submitted a plan to the
15	adjutant general for maintenance and repair of the armory and the adjutant general has
16	approved the plan. A city receiving funds through this grant program shall manage the project
17	at the armory located within that city and the funds may only be used for the specific
18	maintenance and repair projects described in the plan approved by the adjutant general.
