## 6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7	<b>SECTION 1. APPROPRIATION.</b>	The funds provided in this section, or so much of the

- funds as may be necessary, are hereby appropriated out of any moneys in the general fund in
- 9 the state treasury, not otherwise appropriated, and from special funds derived from the workers'
- 10 compensation fund in the state treasury, not otherwise appropriated, to the workers
- 11 compensation bureau for the purpose of defraying the expenses of its various divisions, for the
- 12 biennium beginning July 1, 1997, and ending June 30, 1999, as follows:

## SECTION 2. WORKERS' COMPENSATION CONTINGENCY - EMERGENCY

- 21 **COMMISSION APPROVAL REQUIRED.** The sums appropriated in section 1 of this Act for the
- 22 workers' compensation contingency line item for the biennium beginning July 1, 1997, and
- 23 ending June 30, 1999, may be spent only upon authorization of the emergency commission.

6	65-06.1-04. State reimbursement Reimbursement for liability in excess of
7	collected premiums. Whenever claim liability against the fund credited to the classification of
8	civil air patrol members exceeds the amount of premiums paid into such the fund, such the
9	excess liabilities shall be are a general obligation of the state of North Dakota adjutant general
10	of the North Dakota national guard as the North Dakota wing of the civil air patrol and shall
11	must be reimbursed to the bureau for credit to the workers' compensation fund through
