- 1 A BILL for an Act to create and enact a new subsection to section 45-10.1-03 of the North
- 2 Dakota Century Code relating to the reserved name of a limited partnership; and to amend and
- 3 reenact sections 45-10.1-02 and 45-10.1-08 of the North Dakota Century Code, relating to the
- 4 name of a limited partnership and certificate of limited partnership.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1. AMENDMENT.** Section 45-10.1-02 of the North Dakota Century Code is 7 amended and reenacted as follows:
- 8 **45-10.1-02. (102) Name.** The name of each limited partnership as set forth in its 9 certificate of limited partnership:
- Must contain without abbreviation the words "limited partnership" or the
   abbreviation "L.P." or "LP".
- 12 2. May not contain the name of a limited partner unless:
  - a. It is also the name of a general partner, the corporate name of a corporate general partner or the limited liability company name of a limited liability company general partner; or
  - b. The business of the limited partnership had been carried on under that name before the admission of that limited partner.
  - 3. May not contain any word or phrase indicating or implying that it is organized other than for a purpose stated in its certificate of limited partnership.
  - 4. May not contain the word "corporation", "company", or "incorporated", "limited liability company", or any abbreviation of those words.
- 5. May not be the same as or deceptively similar to the name of any corporation, limited liability company, or limited partnership organized under the laws of this state or licensed or registered as a foreign corporation, foreign limited liability

9	document and which meets all other requirements of this section.	
10	SECTION 3. AMENDMENT. Section 45-10	.1-08 of the North Dakota Century Code is
11	amended and reenacted as follows:	
12	2 45-10.1-08. (201) Certificate of limited partnership.	
13	1. In order to form a limited partnership, a	certificate of limited partnership must be
14	14 executed and filed in the office of the se	ecretary of state. The certificate must set
15	forth:	
16	16 a. The name of the limited partnersh	p.
17	b. The general character of its busine	ess.
18	c. The address of the office and the	name and address of the agent for service
19	of process required to be maintain	ed by section 45-10.1-04.
20	d. The name and address of the prin	cipal place of business of each general

22	22 e. <del>The latest date upon which the lim</del>	ited partnership is to dissolve.
23	23 f. Any other matters the general par	ners determine to include therein.
24	2. A limited partnership is formed at the til	me of the filing of the certificate of limited
25	partnership in the office of the secretary of state or at any later time specified in the	
26	certificate of limited partnership if, in eit	her case, there has been substantial
27	compliance with the requirements of the	s section.
