1. Please estimate the fiscal impact (in dollar amounts) of the above measure for state general or special funds, counties, cities, and school districts.

Narrative:

HB 1467, if enacted, permanently subjects any coal conversion facility to locally assessed property tax in addition to the coal conversion tax beginning in the year following any year in which more than ten percent of the coal consumed is not subjected to the North Dakota coal severance tax. Our investigation indicates that three facilities located in Mercer County have a possibility of being subject to the provisions of HB 1467: UPA Stanton Station, Leland Olds Unit 1, and Leland Olds Unit 2.

While HB 1467, by itself, does not require an increase in property taxes for counties, cities, or school districts, current law allows an increase in dollars of property tax levy by the amount of tax that would have been paid by a property that is added to the assessment rolls that was not included in the base year. If all three facilities would become subject to property tax under HB 1467, it would add approximately \$8.65 million taxable value. Any increase in property taxes depends upon the level of funding the county and school district budget to provide services.

The State Medical Center levies one mill on all taxable property in the state by constitutional provision.
