1. Please estimate the fiscal impact (in dollar amounts) of the above measure for state general or special funds, counties, cities, and school districts.

Narrative:

SB 2021, if enacted, consolidates several separate property tax levies for counties, cities and city park districts into the respective general funds; increases the allowable mill levy for the county general fund from 23 to 110 mills, the city general fund from 38 to 180 mills, and the city park district general fund from four to 40 mills; provides for a consumer price index adjustment to the county, city, and city park district general fund mill rate; and removes the county, city, and city park district general funds from the maximum levy calculations contained in N.D.C.C. § 57-15-01.1.

While SB 2021 increases the allowable mill levy authority for counties, cities and city park districts, it does not require an increase in property taxes. Any change in property tax revenue will be the result of county or city decisions as to the level at which government services will be funded, and not as a result of the passage of SB 2021. This bill alone causes no fiscal effect to the state, counties, cities, or school districts.
