FISCAL NOTE

SENATE BILL NO. 2113

Section 6 of the Bill authorizes the Board to charge a reasonable fee to applicants for accreditation of continuing education courses, classes, or activities. It is anticipated that approximately twenty five applications for accreditation will be filed per biennium. The Board anticipates that the fee for filing an application will be \$25.00, which should cover the Board's cost in processing the application. Thus, per biennium the Board would receive additional revenues in the amount of approximately \$625.00, which would be equal to the cost of processing the applications.

Section 8 authorizes the Board to remove the \$100 cap on annual licensure fees. The Board's current fee is \$50.00. Although the Board has discussed raising its fee in the future, it has not determined a specific amount. It is very unlikely, however, that the new fee would exceed the current statutory cap. Thus, it is not anticipated that adoption of section 8 will increase revenue to the Board.

Section 9 authorizes the Board to assess a late fee for renewal applications. The Board has not specifically addressed the amount of the late fee, but it would probably be around \$20.00. Although a definite number of future late applications can not be determined, it is estimated that 20 late applications will be filed per biennium. Thus, additional revenues in the amount of \$400.00 will be received by the Board by enactment of section 9 and implementing administrative rules.
